# **Approval of Agenda**

# Report of the Auditor General of Canada to the Yukon Legislative Assembly – Yukon Housing – Independent Auditor's Report 2022

Pursuant to Standing Order 45(3), the Standing Committee on Public Accounts considered a report of the Auditor General.

The committee reviewed and edited draft questions for the public hearing on January 31, 2023.
