COVID-19 Pandemic – COVID-19 Vaccines in Yukon – Independent Auditor's Report – 2023 Report of the Auditor General of Canada to the Yukon Legislative Assembly

The committee met with the officials from the Office of the Auditor General of Canada. Mr. Hayes, Mr. Wheeler, and Ms. Meagher answered questions from committee members.
