**ACKNOWLEDGEMENT OF THE TRADITIONAL TERRITORY OF YUKON FIRST NATIONS**

Pursuant to Standing Order 11(7), the Speaker commenced the proceedings by acknowledging the traditional territory of the Yukon First Nations upon which the Legislative Assembly is meeting:

“I would like to begin the 2018 Fall Sitting of the Legislative Assembly by respectfully acknowledging all Yukon First Nations and also that we are meeting on the traditional territories of the Kwanlin Dün First Nation and the Ta’an Kwäch’än Council.

We will proceed at this time with the prayer given to us by former Speaker Sam Johnston. Mr. Johnston was the Speaker from 1985 to 1992 and was the first First Nation Speaker of a Legislative Assembly in Canada.”

**SPEAKER’S STATEMENT**

**Artwork in the Chamber**

Prior to proceeding with the Daily Routine, the Speaker made the following statement regarding artwork in the Chamber.

“Prior to proceeding with the introduction of our pages, the Chair will make a statement regarding the artwork that is now featured in the Legislative Assembly Chamber. Members and others will by now have noticed the four showcases on either side of the Chamber. I will now briefly describe how they got here – how this came to be.

At its first meeting on February 23, 2017, the Members’ Services Board of the 34<sup>th</sup> Yukon Legislative Assembly agreed to form an all-party subcommittee to consider changes to the decor of the Legislative Assembly Chamber. The subcommittee was authorized to make recommendations to the board regarding any such changes. One change that was agreed to was to include more art by Yukon artists in the Chamber.

When the Legislative Assembly first sat in this Chamber on November 2, 1976, the only artwork on display was the tapestry behind me. It is impressive artwork and when we do tours

of the Legislative Assembly, we certainly get a lot of questions about it; however, the artist who created it was not from the Yukon.

The Legislative Assembly office worked with the arts unit of the Cultural Services branch of the Department of Tourism and Culture to identify works of art for display in the Chamber and for arranging the proper manner of display of these works.

The artwork was to be chosen from the Yukon permanent art collection. The collection was created in 1981 by a group that is now known as “Friends of the Yukon Permanent Art Collection”. The Government of Yukon funds the purchase of new acquisitions every year. Since its creation, the collection has grown to more than 450 original works of art created by more than 225 artists. These works are collected for the people of Yukon and pieces from the collection are on display in more than 30 locations in Yukon, including now the Yukon Legislative Assembly.

After careful consideration, eight pieces were chosen from the permanent art collection for display in the Chamber. The pieces are as follows: *Traditional Doll – Girl* by Annie Smith; *Tlingit Eagle Frontlet* by Keith Wolfe Smarch; *Arrival of the Dog Team* by Deb Enoch; *Caribou Flagan* by David Ashley; *Fire Bag* by Gertie Tom; *Raven’s Flight* by Eugene Alfred; *Forget-Me-Not Mukluks* by Mary Deguerre and *Wood-Ash Glazed Vessel With Lid* by Monika Kate Steputh.

The display will be officially unveiled at a reception later this month. The current collection of pieces will be on display until the fall of 2019 and then a new collection will be put on display.

The Chair thanks all members for their attention and looks forward to hosting them and members of the general public at the official unveiling. Thank you.”

### **SPEAKER'S STATEMENT**

#### **Unparliamentary language**

The Speaker made the following statement.

"Before proceeding to Question Period, the Chair will make a statement regarding a remark made and two points of order raised during Question Period on Thursday, October 18, 2018.

During last Thursday's Question Period, in his response to a question from the Member for Lake Laberge regarding health care funding, the Premier said: 'I will not use the term "fearmongering" because that would be out of order...' There are three issues to be addressed with regard to the Premier's statement.

First, a review of *Hansard* reveals that the term 'fearmongering' has a history of some use in this Assembly. Its use has, at times, led members to raise points of order. In those cases where the Chair has ruled the use of the word out of order, it is usually the case that the word has been directed by one member toward another member regarding a specific statement by that member. Such rulings not only address the issue of unparliamentary language but also advise members against personalizing debate.

On other occasions, the Chair has intervened without a point of order being raised to advise a member not to use the term. At yet other times, the use of the word has elicited no comment from the Chair or from the floor.

Briefly – for the record – to the best of my recollection and after a quick review of *Hansard* with the able assistance of Mr. Clerk, I do not believe I have provided an opinion or ruling on the term 'fearmongering' in the 34th Legislature, but my memory is by no means flawless.

So it is not the case that there is a single, standard response to the use of the word. As the Chair said to the House in a statement of April 10 of this year, 'The role of the Chair is not to police a specific list of words or phrases; the role of the Chair is to maintain order during the proceedings.'

As the second edition of *House of Commons Procedure and Practice* says on page 619: 'In dealing with unparliamentary language, the Speaker takes into account the tone, manner and intention of the Member speaking; the person to whom the words at issue were directed; the

degree of provocation; and, most importantly, whether or not the remarks created disorder in the Chamber. Thus, language deemed unparliamentary one day may not necessarily be deemed unparliamentary the following day. The codification of unparliamentary language has proven impractical as it is the context in which words or phrases are used that the Chair must consider when deciding whether or not they should be withdrawn. Although an expression may be found to be acceptable, the Speaker has cautioned that any language which leads to disorder in the House should not be used. Expressions that are considered unparliamentary when applied to the individual Member have not always been considered so when applied “in a generic sense” or to a party.’

The second issue to be addressed is the manner in which the Premier used the word ‘fearmongering’. In the statement on April 10, the Chair reminded the House of the well-established parliamentary principle that members ‘cannot do indirectly what they cannot do directly.’ It is not orderly for a member to use what they perceive to be an unparliamentary expression in the midst of a sentence where the member is claiming to not use it. The Chair would advise the Premier and other members to refrain from doing so in the future.

Finally, in saying that he would not use the term ‘fearmongering’ because that would be out of order, the Premier prejudged how the Chair would rule. The Chair will therefore take this opportunity to remind members that, while they may raise points of order, it is up to the Chair to make the rulings.

The Member for Lake Laberge also raised two points of order during last Thursday’s Question Period. Both had to do with statements made by the Premier. In both cases the Member for Lake Laberge asserted that the context in which the Premier used the words ‘misleading’ and ‘inaccuracies’ amounted to a violation of Standing Order 19(h).

Standing Order 19(h) says, ‘A member shall be called to order by the Speaker if that member... charges another member with uttering a deliberate falsehood.’

The Chair ruled at the time that the words uttered by the Premier did not contravene Standing Order 19(h). However, the Chair also committed to review the record. Upon further review, the Chair is still of the opinion that the Premier’s words did not violate Standing Order 19(h). However, in ruling on the first point of order, the Chair also said that the Premier’s comments were close to contravening said Standing Order. The Chair would advise members that it is their responsibility to ensure their statements and their intent are clear when they initially address a matter, rather than offering a clarification during discussion on the point of order.

The Chair thanks all members for their attention to this statement.”

The Chair will take the matter under advisement and may, if necessary, confer with House Leaders or other members in order to reach a more definitive statement on the matter.

**Mass killing at the Tree of Life synagogue in Pittsburgh**

The Speaker made the following statement.

“Prior to proceeding with the Order Paper, the Chair will, on behalf of the House, make a statement in light of the killing of 11 persons at the Tree of Life synagogue in Pittsburgh on Saturday, October 27.

Mass killings have become all too common. No matter where they occur, they make us all feel less secure. What is particularly disturbing about this attack is that the victims were not chosen at random. The alleged perpetrator admitted to making a targeted attack on people of the Jewish faith. While unexpected acts of violence make us feel less secure, some of us have reason to feel less secure than others.

We must, at this time, denounce anti-Semitism, whether it manifests itself in acts of violence or not. In fact, we must express solidarity with all persons who are targets of violence by other individuals or groups. What is also worrying is a growing concern that the targeting of identifiable individuals or groups of individuals is a by-product of increasingly polarized views.

This event occurred in the United States; however, Canadians and Yukoners cannot rest easy. It may be difficult, if not impossible, in a given situation to establish a direct causal connection between the words spoken by one person and the violent actions of another. However, this is not a risk that we should be willing to take. All of us who participate in the public life of our community need to remember that our words matter. This is not just a matter of avoiding saying things that we should not say; it is also a matter of saying the things that need to be said, expressing support for and solidarity with those who need our support.”

**In recognition of Remembrance Day**

The Speaker made the following statement.

“Before the House proceeds with the Order Paper, the Chair will make a few remarks.

This coming Sunday is Remembrance Day. It is a day when Canadians from coast to coast participate in ceremonies that honour those who have served and continue to serve in the Canadian Forces, the RCMP and other related agencies. At this time, I would like to introduce the Yukon veterans and ex-RCMP who have attended today for this ceremony.

First, we have Doug Bell, my constituent, friend and neighbour, who is a World War II veteran. Welcome, Doug. We have Joe Mewett who is the president of the Whitehorse Royal Canadian Legion Branch 254, and I think I can get the rest in the correct order: Red Grossinger, Dave Laxton, Terry Grabowski, RCMP veteran Ken Putnam, and Morris Cratty. Thank you so much for attending this tribute today and attending the Legislative Assembly.

Every November 11<sup>th</sup> we remember men and women who defended Canada during times of war and continue to bring peace to troubled parts of the world. We are honoured to have veterans and serving members among us today for this commemoration. I would like to thank you so very much for your attendance.

In 2018, we commemorate the 100th anniversary of Canada's 100 Days – a three-month series of victories in the closing months of the First World War. We also commemorate the centenary of the armistice that finally ended the battles of the Great War, tragically misnamed ‘the war to end all wars’.

While Remembrance Day has always been a day to remember those who died in the service of Canada, we are also more aware that the price paid by our service men and women sometimes extends beyond their time in uniform. We must remember this and continue to support these fellow Canadians.

Acts of remembrance come in other forms as well. On October 25, 2018, the Whitehorse Royal Canadian Legion Branch 254 hosted an event where a book entitled *The Yukon Fallen of World War I* was released. Legion branch 254 sponsored the publication of that book that was written by Michael Gates and Blair Neatby. The book documents 101 Yukoners who died in the First World War. For 87 of the fallen, a dedicated page for each soldier has been devoted to telling their story. Where the documentation is incomplete, 14 other soldiers who made the ultimate sacrifice are included in a section near the end of the book.

It is actions such as this that give life to the refrain 'We shall remember them.'

Today is also National Aboriginal Veterans Day. It must be remembered that status Indians in Canada did not have the right to vote or to be candidates for the House of Commons or the Yukon Territorial Council until 1961. In other words, Canada's aboriginal soldiers, sailors and air force personnel who fought in the First World War, the Second World War and in the Korean War fought for rights that they themselves did not yet have.

While remembering the actions of soldiers, sailors and air force personnel during times of war, it is also worth remembering the legacy they have left us. The freedoms we as legislators and as citizens exercise daily exist largely because of the sacrifices made by the brave individuals who have served Canada over the years, sometimes in unimaginably horrible circumstances.

As Members of the Legislative Assembly, we, like all Canadians, are the beneficiaries of freedoms that have been provided for us by the sacrifices of others. It is easy to take all of this for granted. We have been born in a country or have come to this country where these institutions already existed and are supported, not just by laws, but most importantly by the belief Canadians have in them and the commitment that Canadians must make to them on a daily basis.

The establishment of these institutions and the ideals they embody was only possible – and their continued existence is only possible – because there have been and continue to be millions of Canadians, past and present, who were and are willing to serve and risk paying the ultimate price to protect them. Lest we forget."

**In remembrance of Doris McLean, former Sergeant-at-Arms**

The Speaker made the following statement.

“Members and others are aware that Doris McLean passed away in January of this year. Ms. McLean served the Yukon Legislative Assembly as Deputy Sergeant-at-Arms from November 3, 2003, until the end of July 2016 and as Sergeant-at-Arms from July 2016 until her resignation on September 30, 2017.

Ms. McLean, a former chief of the Carcross/Tagish First Nation, was of Tlingit and Tagish ancestry, belonged to the Daklaweidi Killer Whale clan and was the first indigenous person to serve the Yukon Legislative Assembly as Sergeant-at-Arms.

Ms. McLean conducted her official duties with dignity and efficiency and was well liked and highly respected by all those who came in contact with her. Doris McLean was a trail-blazing indigenous woman who led the way of cultural revitalization for family and community.

I would like to take a few moments to provide you with the explanation that was provided to me regarding the purpose of the ceremony today and the songs that the Dakhká Khwáan Dancers will share with you today. They will be singing what are referred to as ‘cry songs’. Cry songs are sung after a person has died by their respective clan members and also by the opposite clans. Celebratory songs in honour of a deceased person are not sung until after their potlatch happens.

Doris McLean is Daklaweidi clan, Killer Whale, under the wolf/eagle side. I spoke to Marilyn Jensen and she told me that one of the dancers has Ms. McLean’s drum here today. The Daklaweidi clan will sing an ancient clan song called ‘Eshaan du keet’. Their opposite, the Deisheetaan and the Gaanaxtedi, will then sing a Gaanaxtedi clan song back to the Daklaweidi clan to hold them up in their sorrow and also to maintain the balance of the two sides.”

The Dakhká Khwáan Dancers then performed ceremony in the Chamber in honour of Doris McLean, former Sergeant-at-Arms.

**SPEAKER'S STATEMENTS**

**National Child Day**

The Speaker made the following statement.

“On this day 29 years ago, the United Nations adopted the Convention on the Rights of the Child. Two years later, in 1991, Canada ratified the United Nations Convention on the Rights of the Child – UNCRC – and established November 20 as National Child Day.

National Child Day is an annual opportunity for Canada to shine a spotlight on the rights of the child. Children’s rights are human rights that have special considerations for the developmental needs of young people as well as the responsibilities of adults to provide support, care and dignity for children. The United Nations *Convention on the Rights of the Child* enshrines 42 rights to health, safety, well-being and education for children that governments must uphold. Canada has a duty to report to the United Nations every five years on how it is safeguarding these rights.

In 2009, the Yukon Legislative Assembly passed the *Child and Youth Advocate Act*, and in 2010, the office of the Child and Youth Advocate was opened. The Child and Advocate Office is an independent office of this Legislative Assembly that supports children and youth in accessing their rights and having their voices heard within government programs and services. In eight years of operation, the Yukon Child and Advocate Office has addressed a multitude of individual advocacy issues for Yukon children and youth. The office encourages everyone to actively promote the United Nations *Convention on the Rights of the Child*, and on National Child Day, they acknowledge and celebrate the many efforts of youth participation.

The office has signed on to the GlobalChild project with Dr. Ziba Vaghri from the University of Victoria. The GlobalChild project is an international project that is conducting focus groups around the world to collect data from youth on how they feel their rights are being upheld by their respective governments. There are 49 focus groups taking place in 39 countries, and nine are taking place in Canada. All of the information that is gathered in these focus

groups will be brought to Geneva, Switzerland next year. The information gathered will be incorporated into a child rights monitoring tool called GlobalChild.

The group here in Whitehorse is the first group in the world to run such a focus group. The group that participated in the first focus group was the Vanier Catholic Secondary School's social justice class led by a teacher who I might know – my spouse, Janet Clarke.

The youth provided their input about: children's rights to special education; if you have a disability, the right to the best health care; the right to have all of your basic needs met; and the right to help from the government if you are poor.

In addition, over the last year, the Child and Advocate Office has worked with the Youth of Today Society on a variety of youth participation projects. Youth of Today Society houses *Shākāt Journal: The Change Project*, a social enterprise with the goal of creating a safe space for youth to explore ideas and access training, mentorship and support to take action. Led by Youth of Today Society, youth receive hands-on training in multimedia skills from podcasts and video creation to story writing and social media promotion. By giving youth the tools to tell their stories, they are able to connect, share their culture and break the cycle of hopelessness, unemployment and racism that many youth face.

In the spirit of reconciliation, *Shākāt Journal: The Change Project*, commonly referred to as "*Shākāt*", has taken on several large-scale projects this year, including *RiverNation: Journey Through the Bloodlines* and the first-ever Millennial Town Hall and youth forum, which the Premier and others participated in.

Each project brought both indigenous and non-indigenous youth from all over the Yukon together to share, connect and learn from teachers, elders, politicians and each other.

The Child and Advocate Office has engaged *Shākāt Journal* to enhance communication and amplify the voices of young people by recording, celebrating and highlighting their contributions. *Shākāt* has provided video and technical support for the following Child and Youth Advocate engagement projects: the latest *Shākāt Journal* features an article about the Child and Advocate Office; *Shākāt* provided social media support, videography and developed baseball cards for all of the youth coaches at the youth rookie league project; and a youth-led reconciliation project funded by the Jays Care Foundation promoting the right to culture and the right to play. They produced a slide show and two videos from the very successful Jays Care Foundation event this summer.

One of the *Shākāt* youth mentors, Jeremy Linville, also known as Tahltan Havoc, led a songwriting workshop and produced a music video about the Jays Care projects, Yukon Rookie League and the field of dreams. The Child and Youth Advocate supported a former youth from care, Carrie Davis, to produce a video about the challenges of ageing out of the care of the director of Family and Children's Services. *Shākāt* youth mentors provided videography and technical support. *Shākāt* is currently working on a project with the support of the Child and Advocate Office to elicit views of young people about youth homelessness. *Shākāt* and the Child and Advocate Office invite all present to join the upcoming homelessness challenge.

At this time, I have the distinct pleasure of introducing a number of people in the gallery involved with both the Child and Advocate Office and *Shākāt*.

I would like to introduce Lancelot Burton; also Paige Hopkins, Alexander Gatensby, Skyler Isaac, Jeremy Linville and Agnieszka Pajor.

From the staff of the Child and Advocate Office, I would like to introduce: Annette King, Child and Youth Advocate; Deputy Child and Youth Advocate Bengie Clethero; Lynda Silverfox, the systemic analyst; Jessica Williams, advocacy caseworker; Stephanie Sullivan, bachelor of social work student; and Carrie Jackson, administrative assistant.

Thank you for your attendance at the Yukon Legislative Assembly today, and thank you for all your work that you do for children and young adults in the Yukon.”

### **SPEAKER’S STATEMENT**

#### **Use of "falsehood" and related terms**

The Speaker made the following statement.

“Before proceeding with Question Period, the Chair will make a statement regarding the points of order raised on Thursday, November 15 by the Minister of Community Services.

The minister raised the points of order during Question Period in response to the repeated use of the word ‘falsehood’, which the Leader of the Official Opposition had directed at the Minister of Education.

The Chair ruled that there was no point of order, but committed to review Hansard and to return to the House with further information, if that was deemed necessary.

Standing Order 19(h) says, ‘A member shall be called to order by the Speaker if that member... charges another member with uttering a deliberate falsehood.’ As mentioned, the word ‘falsehood’ was used a number of times during last Thursday’s Question Period by the Leader of the Official Opposition, the Member for Lake Laberge and the Minister of Education. That Question Period also featured the Premier’s use of the terms ‘misleading information’ and ‘misinformation’, as well as an allusion to Pinocchio, Chicken Little and the boy who cried wolf.

To begin, the Chair will reiterate a statement that he has made in the House on previous occasions in dealing with matters of order and disorder: the role of the Chair is not to police a specific list of words and phrases; the role of the Chair is to maintain order during the proceedings.

The Chair will also repeat a point he has made in dealing with previous points of order regarding Standing Order 19(h). It is significant that Standing Order 19(h) prohibits members from accusing other members of uttering a ‘deliberate falsehood.’

To quote annotation 494 of the sixth edition of *Beauchesne’s Parliamentary Rules and Forms*: ‘It is not unparliamentary to temperately criticize statements made by Members as being contrary to the facts; but no imputation of intentional falsehood is permissible. On rare occasions, this may result in the House having to accept two contradictory accounts of the same incident.’

In other words, members are not to be called to order because they assert that another member has furnished the House with information that is false, inaccurate or wrong. Members are called to order when they are found to have accused another member of having deliberately furnished the House with information that is false, inaccurate or wrong.

This distinction is important because the Chair is trying to maintain a debate dynamic and atmosphere in the House where members can, in an orderly fashion, exercise their fundamental privilege as Members of the Legislative Assembly: that of freedom of speech.

The Chair understands that members are debating issues of importance to Yukon and Yukoners and that they, in some cases, have profound and fundamental disagreements with one another about the proper direction of government policy. Members must be able to vigorously engage in debate, ask the questions they wish to ask and respond in the manner they see fit without fear of being called to order because they have taken issue with facts or information presented by another member.

Members must also accept the fact that they will receive criticism – sometimes pointed criticism – about the way in which they are exercising their public duties. In fact, they may – not infrequently – have their words or actions interpreted in a manner with which they disagree. That is also a fundamental aspect of the Westminster parliamentary tradition.

As mentioned, the Chair's primary role in the House is to ensure that the proceedings are orderly. In this Chamber, members – as the ones who are asking questions, providing responses and making speeches – also play an important role in ensuring that proceedings are orderly. It is the Chair's observation that the proceedings in this Assembly are generally not very disorderly. Of course, incidents of disorder do occur. However, they do not occur with frequency and they do not usually impair the proceedings for very long.

Before concluding this statement, the Chair will comment on the Pinocchio reference. It may be possible, through some as-not-yet-contemplated or -actualized turn of phrase, for a member to refer to another member as Pinocchio in such a way that it does not constitute an accusation of lying; however, the manner in which the Premier made the reference last Thursday is not one of them. The Premier – or any other member – can expect to be called to order if a similar reference is made in the future.

Finally, the Chair will remind members of two fundamental principles of parliamentary debate: that members are to treat each other as honourable and they may not do indirectly what they may not do directly. Therefore, members cannot immunize themselves from being called to order because they phrase their allegation of deliberate falsehood in the form of a rhetorical question.

The Chair thanks all members for their attention to this statement.”
