brief the committee on matters related to the performance audit report on procurement and contracting.

The committee met with the officials from the Office of the Auditor General of Canada. Normand Lanthier, Glenn Wheeler, Nathalie Robertson, and Émilie Anne Duval answered questions from committee members.

The officials from the Office of the Auditor General of Canada were excused from the meeting at 1:25 p.m.

Scheduling Future Business

The committee reviewed that it had previously agreed to hold a public hearing on the *Yukon Public Accounts 2023-24* at 1:00 p.m. on Tuesday, January 14, 2025, and a public hearing on the performance audit report on procurement and contracting at 1:00 p.m. on Thursday, January 16, 2025.

It was reviewed that the deadline agreed to for committee members to provide their proposed questions for both public hearings is 1:00 p.m. on Friday, December 13, 2024.

The committee discussed scheduling a meeting to review the proposed hearing questions. It was agreed that the committee next meet at 1:00 p.m. on Monday, December 16, 2024. The Chair noted that he would not be in attendance and the Vice-Chair would therefore preside at the meeting.

The committee clerk was tasked with preparing an invitation to the Deputy Minister of Finance to appear at the January 14, 2025, public hearing and an invitation to the Deputy Minister of Highways and Public Works to appear at the January 16, 2025, public hearing.

Further discussion on potential witnesses for the January 16, 2025, public hearing on the procurement and contracting audit was deferred to the next meeting.

Other Business

Committee members noted that the committee had received a letter, dated November 15, 2024, from the Office of the Auditor General of Canada regarding upcoming performance audit reports. The audit on the Yukon Nominee Program and Yukon Nominee Business Program has been paused and will not be presented to the Legislative Assembly in 2025, as planned.
