This being the day appointed for the opening of the First Session of the Thirty-sixth Wholly-Elected Legislative Assembly of Yukon for the dispatch of business and the oaths having been already administered to the Members of the Legislative Assembly, the Members took their seats in the House.

Proclamation

The Clerk of the Legislative Assembly, Dan Cable, read the Proclamation as follows:

Report on Members Elected

The Clerk of the Legislative Assembly reported on the members elected to the Yukon Legislative Assembly as follows:

“Honourable members, the following letter, dated November 12, 2025, was sent by the Chief Electoral Officer of Yukon to the Commissioner of Yukon, the Hon. Adeline Webber:

‘Dear Commissioner:

As required by section 308 of the *Elections Act*, I am pleased to advise you that the returns of the writ for the general election of Members of the Yukon Legislative Assembly and a plebiscite vote, held on November 3, 2025, have been received.

The returning officers have certified in their return of the writ that the 21 members duly elected for their electoral district by having received the largest number of votes lawfully cast are:

When the writ was issued on October 3, 2025, the date of the return of the writ was set as November 10, 2025. A recount was applied for in the district of Vuntut Gwitchin as there were 10 votes or less between the candidate with the most votes and one other candidate. The Supreme Court of Yukon set the date of the recount as November 12, 2025. The recount, held today under Justice Karen Wenckebach, confirmed the vote tally.

In the event the return of the writ date is required in accordance with *the Yukon Act* section 11(1), the date of the return of the writ is November 12, 2025. The *Yukon Act* states that “no Legislative Assembly shall continue for longer than five years after the

date of the return of the writ for a general election, but the Commissioner may dissolve it before then.”

Clerk advises House that Commissioner will not deliver Speech from the Throne until Speaker is elected

The Commissioner, the Hon. Adeline Webber, entered the Chamber and took the Chair. The Clerk of the Legislative Assembly then stated:

“I am commanded by the Commissioner, in her capacity as Lieutenant Governor, to state that she does not see fit to declare the causes of the summoning of the present Assembly of this territory until the Speaker of this Assembly shall have been chosen according to law, but today, at a subsequent hour, she will declare the causes of the calling of this Assembly.”

The Commissioner then retired from the Chamber.

ELECTION OF SPEAKER

The Clerk addressed the House:

“Honourable members, nominations are invited for the Office of Speaker of this Assembly.”

Motion No. 1 – Election of Yvonne Clarke as Speaker

Moved by the Hon. Currie Dixon, Premier, and seconded by Kate White, Leader of the Official Opposition, and Debra-Leigh Reti, Leader of the Third Party:

THAT Yvonne Clarke, Member for Whistle Bend North, do take the Chair of this Assembly as Speaker.

The Clerk, having scanned the House for further nominations, repeated the motion and called for a vote. He then stated:

“The yeas have it, and Yvonne Clarke, Member for Whistle Bend North, is, by direction of this Assembly, duly elected as Speaker of the Yukon Legislative Assembly.”

SPEAKER’S ADDRESS TO THE ASSEMBLY

The Speaker retired from the Chamber, donned her robe and re-entered the Chamber.

The Speaker took her seat and thanked the Assembly as follows:

“Members of the Legislative Assembly, I rise today with deep gratitude and a profound sense of responsibility. I thank this Assembly for the confidence it has placed in me. To be elected Speaker of the Yukon Legislative Assembly is among the greatest honours a member may receive, and I accept this role with humility, with resolve, and with a clear understanding of the duty before me.

Today is historic. Together, this House has elected the first Filipina-Canadian woman Speaker in Canada. That milestone does not belong to me alone; it belongs to every Yukoner who has ever stepped forward with courage, to every immigrant who arrived with hope in their pocket, and to every person who believed that this beautiful territory in the North could be their home, their future, and their place to serve.

It is a powerful reminder that our democracy grows stronger when more voices from more journeys, cultures, and histories have a seat in decision-making. Representation is not symbolic; it is structural. It shapes how we see one another, how we govern, and how we build trust as a society.

To the Speakers and leaders who came before me, maraming salamat po. You upheld decorum, protected the rights of members, and guided debate with steady hands. I inherit a legacy that I do not take lightly, and I intend to protect and honour it.

To the Clerks, Table Officers, Sergeant-at-Arms, pages, Hansard, security, maintenance staff, and all those in the legislative office who keep this institution standing upright and moving forward, maraming salamat sa inyong lahat. You are the unsung heroes of our proceedings. When the House is sitting, you keep the gears turning quietly and flawlessly so members can do the work Yukoners sent us here to do. We see you; we appreciate you.

To my constituents, the residents of Whistle Bend North, thank you for the privilege to serve. I bring your hopes, concerns, and determination into this Chamber each day. Without your trust, I would not be here.

To my spouse Peter, the wind beneath my wings for 18 years, your steadiness, your counsel, and your faith in me have carried me further than I ever imagined I could go. And to my children, Rachel, Sabrina, and Sean, my determined, compassionate adults who continue to cheer on their immigrant mom, whose English is her third language, salamat mga anak. You embrace my accent the way one embraces heritage: not as something to correct but something to be proud of. From editing my grammar from afar to offering advice, clarity, and perspective when I need it most, you have lifted me every step of the way.

Members of the Legislative Assembly, the Speaker must be firm and absolutely impartial. I pledge to serve every member equally – Government benches, Opposition benches, and every independent voice. I will uphold our Standing Orders, protect the rights of all members, and ensure that debate, even when passionate, remains respectful, principled, and worthy of public confidence.

Former Speaker of the UK House of Commons, John Bercow, once said, “Some people say, ‘We like the way he speaks.’ Others say, ‘He’s an irritating clot.’ My argument is that I am authentic.”

I suspect I may experience the same, particularly as a Filipina-Canadian who occasionally pronounces things the Filipino way. So, if from time to time, you hear a vowel shaped by Cebuano or Tagalog, rather than Oxford English, I trust the House

will offer patience and perhaps even forgiveness equal to that offered in Question Period.

Now I ask each of you for your continued goodwill, your respect for this institution, and your commitment to conduct that strengthens rather than erodes our democracy. We do not always have to agree, but we must always listen. We must always remember that our work here belongs to the people, not to ourselves. This Chamber is where Yukon voices meet. It is where difficult decisions are debated and where the future of this territory is built piece by piece. The Speaker does not command the House; the Speaker guides it – not to silence but to ensure that every voice, every perspective, and every member has their rightful place.

Let us move forward together, respectful in disagreement, united in purpose, and confident in the strength of this Assembly and the people we serve. Let us set an example for future generations and show that, even in a world of sharp divides, the Yukon can lead with civility, dignity, and democracy that works.

Members of the Legislative Assembly, thank you once again for the trust you have placed in me. I will strive each day to be worthy of it. Maraming salamat po.

Clerk, will you please advise the Commissioner, in her capacity as Lieutenant-Governor, that the Assembly is now prepared to hear the Speech from the Throne."

The Speaker then addressed the Clerk as follows:

"Clerk, will you please advise the Commissioner, in her capacity as Lieutenant Governor, that the Assembly is now prepared to hear the Speech from the Throne."

The Commissioner returned to the Chamber and took the Chair.

SPEAKER'S ADDRESS TO THE COMMISSIONER

The Speaker then said:

"Madam Commissioner, the Members of the Legislative Assembly have elected me to be their Speaker, and I recognize the important duties now given to me. If, in the performance of those duties, I should at any time make a mistake, the fault is mine and not that of the Assembly, whose servant I am. At this time, so that all members of the Assembly can best carry out their duty to Yukon, to their country, and to the King, I would claim for them their undoubted rights and privileges, especially freedom of speech in their debates, access to your person when necessary, and your favourable consideration of their proceedings."

RESPONSE BY THE COMMISSIONER

The Commissioner then said:

"Madam Speaker, I am pleased to declare to you that I believe in the duty of the Assembly and, not doubting that the Assembly's proceedings will be conducted with wisdom, temper, and care, I grant and allow the Assembly's constitutional privileges. I

assure you that the Assembly shall have ready access to me and that the Assembly's proceedings, words, and actions will receive from me favourable consideration."

SPEECH FROM THE THRONE

The Commissioner then delivered the Speech from the Throne as follows:

"Honourable Members of the Yukon Legislative Assembly, respected elders, chiefs and councillors, distinguished guests, and those watching and listening remotely across the territory, it is my honour to welcome you to the 36th Yukon Legislative Assembly.

We meet today on the traditional territories of the Kwanlin Dün First Nation and the Ta'an Kwäch'än Council, and we acknowledge with gratitude all Yukon First Nations whose lands and waters sustain us. Yukoners are among the most blessed people in the world. We are the inheritors of a proud legacy shaped by those who came before us, beginning with the 14 Yukon First Nations who built the territory's first communities. They were later joined by prospectors and other adventurous souls who left the comforts of home and family to forge a new life in a distant and rugged land. The attributes that sustained these early pioneers and our First Nation ancestors — self-reliance, resilience, determination, and community spirit — live on in all of us.

In Yukon, where you are going matters more than where you are from. If you are willing to work hard, you can find an opportunity to build a life here — something more and more people are choosing to do. Once thought of as a hinterland, Yukon continues to draw people from across the country and around the world. Adding diverse viewpoints and experiences, these new arrivals are enriching the territory's cultural fabric and enhancing our dynamism.

As our territory grows, so too does our self-assurance about our place in Canada and what we have to offer the world. This budding confidence will be on display in a few short months, when we welcome more than 2,000 participants from northern Canada, Alaska, Greenland, and other circumpolar regions to compete in the Arctic Winter Games.

As the athletes showcase their skill, their strength, and their determination in 20 sporting events, the territory will showcase what makes us the best place in the world to live, work, and play.

The Government is proud of what Yukoners have built together and is inspired by the territory's bright future. It is committed to helping Yukon seize the immense opportunities that lie before us. The territory needs to be a place where people are encouraged to dream as big and as bright as the northern lights, a place where those who take risks are rewarded, a place where young people can stay and build a future, a place where everyone, regardless of their background, can get ahead through hard work, a place where people do not have to settle for good enough, but are empowered to build the life that they want and deserve. These are the promises that the new government will work on to restore.

A new direction. On November 3, Yukoners voted for change. They voted for a government that listens, not dictates; a government that offers solutions, not excuses; a government that always puts hard-working Yukoners and their families first. The Government's work will be guided by five foundational values.

The first is leadership. The Government will take decisive action to realize its ambitious vision for the territory. If mistakes are made, they will be addressed and acknowledged. True leadership means having the strength to change the course.

Second, the Government's work will not take place in a silo. Collaboration will be the key to everything it does. Listening to Yukoners, reaching out across the aisle, and working effectively with the public service, First Nations, and other orders of government will create significant synergies and deliver better results for Yukoners.

Excellence is the third foundational value. The Government will pursue continuous improvement in everything it does. While it may not always be achieved, doing the right thing the first time will always be the goal. When the current approach falls short, the Government will not hesitate to forge a new path, which leads to the fourth foundational value: innovation. Better is always possible if you're willing to buck the status quo. The Government will seek and value ideas, and support risk taking when warranted.

The final foundational value is efficiency and effectiveness. The Government will save time and resources by making decisions closer to where the work happens, an approach that will rely on the expertise and advice of public servants. The Government will also cut all unnecessary red tape, as paperwork for its own sake undermines growth and progress.

Taken together, these foundational values — leadership, collaboration, excellence, innovation, and efficiency and effectiveness — will guide the government's actions.

Raising the roof on housing. While the Government has great optimism for the future, it is also realistic about the challenges ahead. The inevitable results of wrong-headed policy and bad decisions have damaged the social contract. Even though Yukoners are working harder than ever before, many feel that they are not getting ahead and, in some cases, are actually falling behind. Not long ago, Yukoners could find an affordable place to call home. Sadly, that is no longer true. Our population growth has been a boon to the territory in so many ways, but it has also put a tremendous strain on the housing market, our health system, and infrastructure.

Between 2018 and 2025, the population of Whitehorse alone grew by more than 5,200 people. The results have been predictable: during that period, the average cost of a single detached home in the territory increased by nearly 50 percent, far outpacing the wage increases.

In the next five years, our capital city is expanding to welcome more than 4,000 new residents. Despite doing all the right things, including working hard and saving

up, home ownership is increasingly beyond the reach of many Yukoners. Home ownership is so much more than putting a roof over your head or an opportunity to build equity; your home is where you make memories and provide a foundation for your family. In a territory as land rich as Yukon, this is as tragic as it is unacceptable. The Government will take immediate action to streamline land development in the territory. Recognizing that home builders construct the vast majority of housing, the government will reform the land lottery and ensure that they have access to more lots. It will increase the land supply further by working with the City of Whitehorse and the federal government to acquire vacant or abandoned lots for housing and mixed-use development.

Not all Yukoners aspire to home ownership, so the Government will also work to create a healthier rental market, beginning with phasing out the rent cap that forced many landlords to remove their units from the market.

Keeping the lights on. Housing is not the only place where Yukoners are feeling the pinch, whether it's groceries, building materials, or insurance, everything costs more — often considerably so — than it did five years ago. While many factors driving inflation are outside of the territory's control, steps can be taken to provide some much-needed relief. Yukoners are on track to have some of the highest electricity bills in Canada. In a place enveloped by darkness for more hours than not during much of the year, keeping the lights on is a necessity, not an option. To keep more money in people's pockets, the Government will insulate Yukoners from the proposed power rate hikes. Further to that, the Government will work with Yukon Energy to build cost-effective energy infrastructure for the future.

Caring for Yukoners. Few issues matter more to Yukoners than health care. This is unsurprising as no area of public policy impacts us and our loved ones so intimately. A vibrant Yukon needs a robust health system. Unfortunately, thousands of Yukoners cannot access the health care they need when they need it. Health care infrastructure has simply not kept pace with Yukon's growing and aging population. The signs of a system in crisis are everywhere, including growing surgical wait times and rural health centres that are struggling to keep their doors open.

The Government will strengthen the territory's health care system and improve health outcomes for Yukoners. The foremost priority will be recruiting and retaining more front-line health care professionals. Doctors and nurses in the United States, the United Kingdom, Australia, and New Zealand are trained to a similarly high standard, so they will be the primary focus.

An increasing number of American doctors are open to moving given concern with the political climate of the United States. The Government will launch a marketing campaign aimed at these health care professionals, selling them on Yukon's unparalleled quality of life and the advantages of practising in a single-payer system.

In partnership with health care professionals and Yukon First Nations, the Government will improve the health care system, including reassessing the Health Authority, to ensure patients and families come first.

Strong stewards. Yukoners take pride in caring for one of the world's most untouched natural environments. Lately, hunters, anglers, and trappers have faced fewer opportunities and inconsistent decisions. This has made it harder to trust the process and has weakened the teamwork that once made Yukon a leader in conservation.

By respectfully working with First Nations, investing in wildlife data and habitat protection, and creating fair, open processes for hunters, anglers, and outdoor enthusiasts, the government will make sure that conservation and opportunity go hand in hand.

Refocusing on Education. During the election campaign, the government heard a clear and consistent message from Yukon families: Our education system is not working as well as it should be. Their concerns are backed up by evidence. Report after report has found that the current system is not helping Yukon students meet their full potential. The Government will restore accountability and direction to the territory's education system by putting students and educators at the centre of every decision. It will restructure the Department of Education to ensure that it actually helps students advance.

In keeping students focused on learning, the Government will move to keep cell phones out of the classroom. Seemingly a small step, the ban will go a long way to enhancing the social interactions and improving mental health. Yukon's education system will bring new focus to the skilled trades, so we have the skilled hands we need to build our future.

Finally, the Government will work with First Nations, whether through the First Nation School Board or government-to-government, to foster reconciliation in a learners-first, strength-based, community-centred approach.

Safety for Yukoners. Yukoners have seen a disturbing rise in crime and social disorder. It was not too long ago that the territory boasted some of the safest communities in Canada. Now, Whitehorse has a violent crime rate surpassing many big cities across North America — a shocking development for those who grew up here.

No longer just a city problem, crime is also wreaking havoc in smaller communities too. Trust in the justice system is at an all-time low, with victims feeling overlooked, criminals feeling emboldened, and law enforcement feeling unsupported. The Government will take decisive action to tackle the current crime wave, beginning with conducting a comprehensive review of the Whitehorse Emergency Shelter, its operating model, and potential alternative locations and options for sheltering services. It will also work with the RCMP to strengthen enforcement efforts in the area. We will also take action to better address repeat and violent offenders and their supervision in

our communities. We will make investments in the justice system, including the courts, to reduce re-offending and to support victims of crime. We will also work with Canada to push for bail reform.

Residences and businesses have suffered long enough and deserve better. Enforcement and prevention need to go hand in hand. To this end, the Government will increase addiction treatment options to keep vulnerable people from falling into a life of crime in the first place. Yukoners deserve safe communities where their families can thrive and their businesses can prosper. That is why policing resources should be focused on crime rather than confiscating peoples' lawfully acquired property.

Hunting and shooting are foundational to Yukoners' way of life, particularly to First Nations exercising their constitutional rights. Unlike criminals, the territory's gun owners are thoroughly vetted law-abiding citizens, and that is why the government will take action to support the rights of legal gun owners in this territory, and we will advise the Government of Canada that the Yukon Government will not participate in Ottawa's firearms buy-back program.

Taking care of business. A strong territory requires a thriving economy powered by a dynamic private sector. Yukon's private sector plays an invaluable role, but it cannot be the basis for our economy. Between our bountiful natural resources and immense human capital, Yukon has everything we need to succeed. What is required now is a government that gets out of the way and lets entrepreneurs do what they do best: Create jobs and generate prosperity.

The Government's goal is to make Yukon the best place in Canada to build and grow businesses. The first step will be to pause and reassess the extended producer responsibility program, which is imposing increased costs and red tape on small businesses. The Government will also launch a review of the territory's immigration policies to balance the needs of our growing economy with the capacity of our infrastructure to support Yukoners. To provide fairness in procurement and better value for tax dollars, the Government will also take immediate steps to improve the procurement system.

Sound governance. Sound governance is at the heart of good government. When accountability, transparency, and responsiveness wane, trust in our public institution declines to the great detriment of our democracy. A government that cannot engender trust cannot truly lead.

The Government is committed to restoring trust in how decisions are made and ensuring that government works for all Yukoners. Building trust begins with building more respectful and collaborative relationships. Yukon professional and diligent public servants are the foundation of the services and programs on which Yukoners rely.

Unfortunately, morale has fallen in recent years. Far too many public servants feel unheard and disregarded, and front-line services are suffering as a result. A respectful relationship between the political decision-makers and the professional

public service is crucial. The Government will empower public servants to develop and deliver services, and deliver advice, options, and critical thinking to inform sound decision-making. As experienced professionals, their ideas are valuable and their advice matters.

The Government will also forge stronger relationships with Yukon First Nations. The territory is rightfully proud to be a Canadian leader in land claims, self-government, and collaborative governance, but much work remains. The Government will work collaboratively in bilateral and multilateral forums to advance the implementation of land claims and Yukon First Nation self-government agreements.

The Government will also work with non-treaty nations to advance self-determination and economic reconciliation. This is a critical step in Yukon's journey toward reconciliation, an opportunity to learn from the past so we can move forward together, stronger and more united.

In conclusion, Yukoners should be proud of their past and optimistic about their future. Lifted by our enviable legacy, we look onto a horizon that is as vast as the territory's promise. A wealth of opportunities lie before us; we just need the vision and confidence to seize them. Yukon is a compact between the past, present, and future. Inspired by those who came before us, we must build today to secure a better tomorrow for those who follow.

That is the Yukon way: Honouring the past, embracing the present, and thinking of the future. Inspired by the accomplishments of our forebearers, we can do great things to advance Yukon's promise for future generations. With the efforts and contributions of the members of this Assembly, the Government looks forward to using this legislative session to help advance Yukon's promise.

SPEAKER'S STATEMENTS**Question Period roster**

The Speaker made the following statement regarding the roster for Oral Question Period:

“I have been informed through the Clerk that we don't as yet have a consensus for the schedule of questions for Question Period. I understand that Question Period rosters are never perfect and must take into consideration the need to hold Government to account while balancing the needs of private members to question the ministers of the Government.

I am also aware that members make the rules of the Assembly and that it is my job to interpret them. In the case of Question Period, the members have not been specific in their intentions in the Standing Orders with respect to rosters. This is probably due to the fact that roster-making is inherently difficult and usually in need of compromise to ensure that all members have a fair chance to ask questions.

In the past in this Assembly, the Government private members have been basically prevented from asking questions due to the nature of their positions on the roster. I agree that Government private members should not have the first, second, or even, in most cases, the third position on the roster. This does not mean that they should never be able to ask questions on behalf of their constituents to the Government of the day.

In reviewing the history of Question Period, I would note that up until 1996, the Assembly had a 40-minute Question Period. In 1996, the members changed the length of time for Question Period to 30 minutes. From the 1970s, the number of members in the Assembly has grown from 16 members at the beginning of the modern era to 21

members now. The responsibilities of the territory and size of the budget have grown along with the population during that time.

As Speaker, I believe that we are past due for the Standing Committee on Rules, Elections and Privileges, or SCREP, to review Question Period and report to this Assembly on its findings. Until that time, I have made some adjustments to the draft roster circulated by the Clerk and will use the roster that I will now table for the members, which is based on what I heard yesterday at a meeting I had with the House Leaders.

I will also inform members that during Question Period, members should be reasonably succinct in their questions and in their replies, and members should get up quickly so that we don't waste time during Question Period. If I find that the members are moving too slowly, I will remind members again, and if it continues, then I will direct the Clerks to start timers in such a way as to speed up the proceedings. I would ask that members of SCREP turn their attention to the issues surrounding Question Period as soon as possible and report back to the House in the Spring Sitting."

Pursuant to Standing Order 76(1), the Chair shall now interrupt proceedings and, with respect to each appropriation bill before Committee that the Government House Leader directs to be called, put the question, without debate or amendment, on a motion moved by a minister that the bill, including all clauses, schedules, title, and preamble, be deemed to be read and carried.

The Chair shall then put the question on a motion moved by a minister that the bill be reported to the Assembly and, when all bills have been dealt with, recall the Speaker to the Chair to report on the proceedings of the Committee.

The Chair will now ask the Government House Leader to indicate whether the appropriation bill now before Committee of the Whole should be called.”

The Hon. Scott Kent, Government House Leader, directed that Bill No. 200, *Second Appropriation Act 2025-26*, be called at this time.

Bill No. 200, *Second Appropriation Act 2025-26*

Ordered, on motion of the Hon. Currie Dixon, Premier:

THAT all clauses, schedules, the preamble, and the title of Bill No. 200, *Second Appropriation Act 2025-26*, be deemed read and carried.

The Chair rose to report to the House and the Speaker resumed the Chair.

Chair’s report to the House

Patti McLeod, Chair of Committee of the Whole, reported Bill No. 200, *Second Appropriation Act 2025-26*, without amendment. The report was carried.

SPEAKER’S STATEMENT**Third Reading of Bills as per Standing Order 76(2)**

‘... the Speaker of the Assembly, when recalled to the Chair after the House has been in the Committee of the Whole, shall: ...
