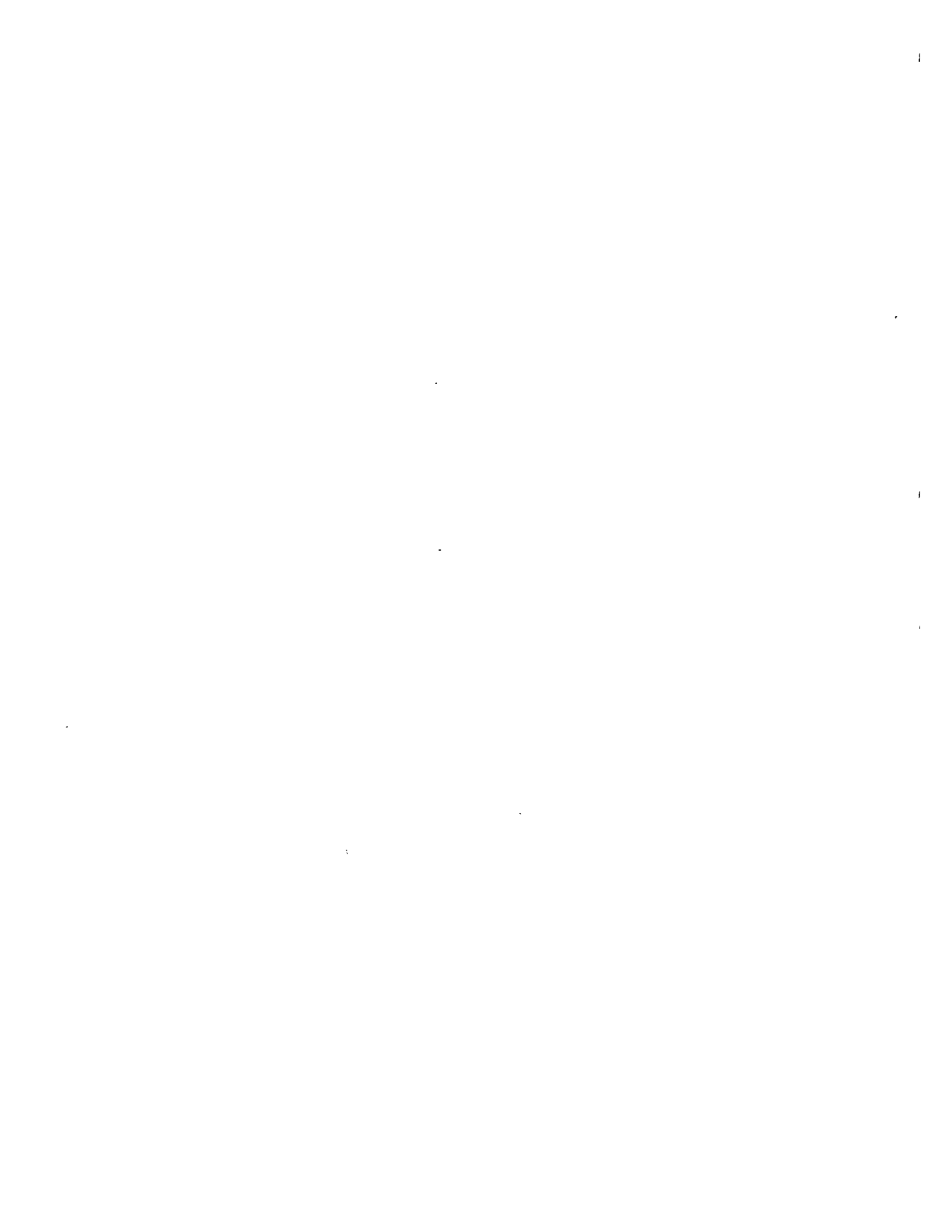

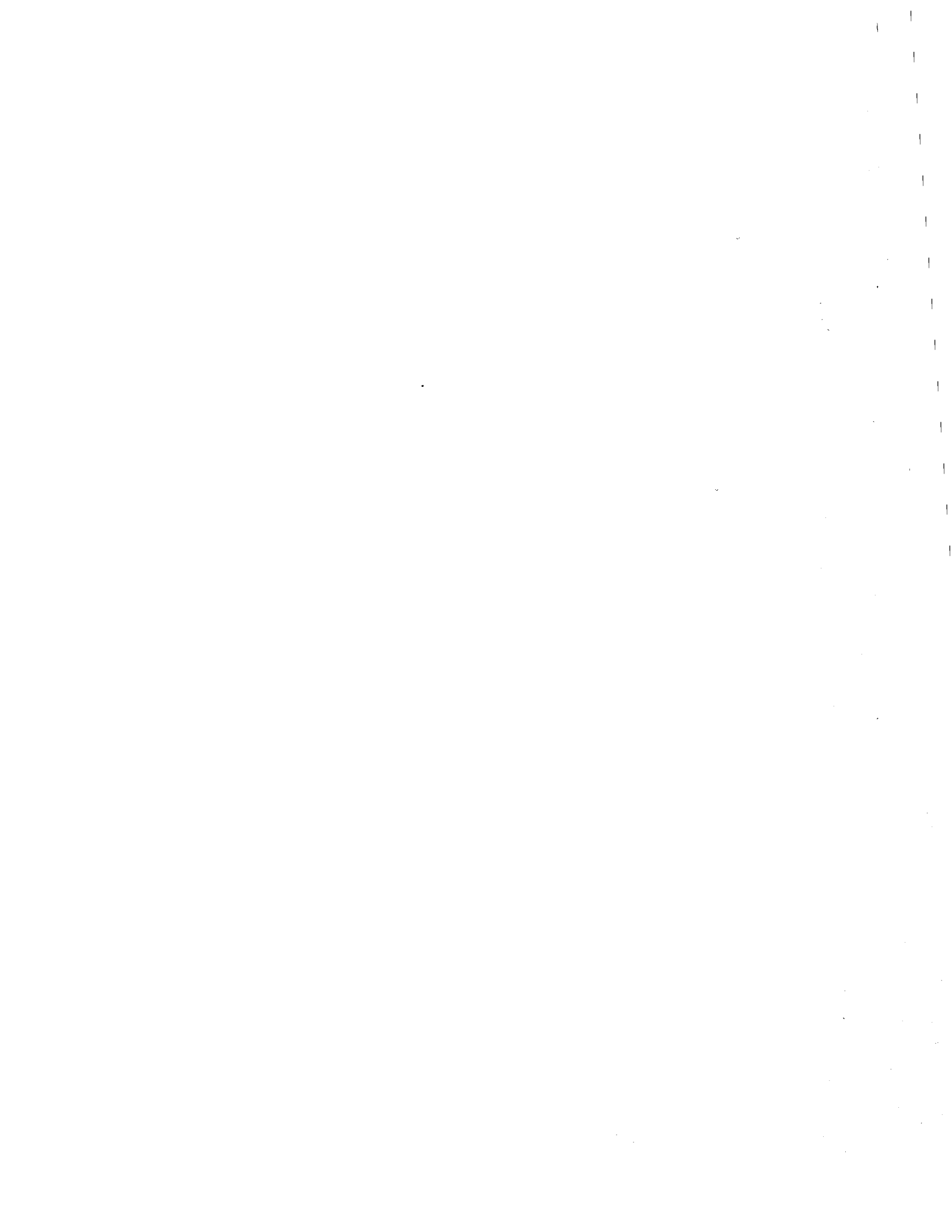

The question is an appeal to the Speaker of a decision of the Chairman of Committee of the Whole, under provisions of Standing Order 42(4), as follows:

When Bill #55 was being considered in Committee of the Whole in general debate, the Member for Porter Creek East raised a point of order that the Minister of Community and Transportation Services was quoting from a formal document and that it should be tabled. Upon debate, I referred to Beauchesne Section 327, read it, then stated that I did not feel that the Minister was quoting from what could be considered to be a formal document.

This was the piece of paper in question which is, as you can see, handwritten notes barely legible. Thus, I ruled that it was not a formal document and there is no point of order, whereupon the Hon. Member for Porter Creek East appealed to the Speaker for a decision from the Chair.

Thereupon, the Speaker requested discussion on the point made by the Chairman and then ruled as follows:

I would refer the Members to Annotation 327(1) where it reads, "A Minister of the Crown is not at liberty to read or quote from a dispatch or other state paper not before the House, unless he is prepared to lay it on the table."

Section 327(6), "If a Minister cites or quotes an official document in debate, he should be prepared to table it."

I find that the Minister has not quoted from an official document and therefore is under no obligation to table anything.

The Assembly, according to Order, again resolved into Committee of the Whole.

WHEREAS it is fundamental to the health and welfare of all Yukon people that safe and affordable therapeutic pharmaceuticals be available; and

WHEREAS Section 41(4) of the Canada Patent Act (1969) has created a situation where Canadian licensees can produce low-priced generic substitutions of brand name pharmaceuticals to be marketed in Canada; and

WHEREAS these generic substitutions have saved Canadians approximately \$200 million per year; and

WHEREAS these generic substitutes have resulted in lower Yukon hospital pharmacare and prescription costs; and

WHEREAS the proposed changes to the Act will result in higher costs for publicly funded health and hospital programs and higher prescription costs for individual Yukoners while providing no benefits to Yukoners; and

WHEREAS the Federal Government in the face of constant pressure from the multinational drug companies and the United States administration has tabled a Bill to amend the Patent Act;

THEREFORE, BE IT RESOLVED, THAT this House urges the Federal Government to abandon amendments to the Patent Act which would result in higher costs for all Yukoners.

SPEAKER'S RULING

The Speaker ruled as follows:

BEFORE CALLING FOR QUESTION PERIOD I WISH TO PROVIDE A RULING ON A QUESTION OF PRIVILEGE WHICH WAS RAISED BY THE MINISTER OF JUSTICE ON THURSDAY, NOVEMBER 27. THE MINISTER OF JUSTICE SAID, IN REFERRING TO REMARKS MADE BY THE MEMBER FOR WHITEHORSE RIVERDALE SOUTH, THAT:

"THE MEMBER OPPOSITE HAS ACCUSED MEMBERS ON THIS SIDE, INCLUDING MYSELF, OF PROMPTING THE SPEAKER. THAT IS A COMMENT THAT MUST BE WITHDRAWN."

IN CONSIDERATION OF THIS MATTER I WOULD REFER MEMBERS TO ANNOTATIONS 52 AND 117 IN BEAUCHESNE. ANNOTATION 52(1) STATES:

"THE SPEAKER SHOULD BE PROTECTED AGAINST REFLECTIONS ON HIS ACTIONS."

A PORTION OF ANNOTATION 117(1) STATES:

"REFLECTIONS UPON THE CHARACTER OR ACTIONS OF THE SPEAKER MAY BE PUNISHED AS BREACHES OF PRIVILEGE. HIS ACTIONS CANNOT BE CRITICIZED INCIDENTALLY IN DEBATE OR UPON ANY FORM OF PROCEEDING EXCEPT BY WAY OF A SUBSTANTIVE MOTION."

THE CHAIR HAS REVIEWED THE REMARKS OF THE MEMBER FOR WHITEHORSE RIVERDALE SOUTH TO DETERMINE WHETHER REFLECTIONS WERE MADE ON THE ACTIONS OF THE SPEAKER. THE MEMBER SAID:

"I FIND THAT THAT SIDE OF THE HOUSE IS CONSTANTLY PROMPTING THE SPEAKER. I HAVE CONFIDENCE THAT YOU, MR. SPEAKER, WILL RULE WHEN YOU FEEL THAT THE SENTENCE IS THE SECOND OR THIRD SENTENCE."

THE CHAIR FEELS THAT THESE REMARKS ARE NOT REFLECTIONS ON THE ACTIONS OF THE SPEAKER AND I, THEREFORE, FIND THAT THERE IS NO QUESTION OF PRIVILEGE.

THE CHAIR DOES WISH TO ADVISE MEMBERS, HOWEVER, THAT MEMBERS MAKING THESE KINDS OF REMARKS SHOULD GIVE CAREFUL CONSIDERATION TO WHAT THEY ARE SAYING AS STANDING ORDER 19(1)(J) STATES THAT THE SPEAKER IS REQUIRED TO CALL A MEMBER TO ORDER IF THAT MEMBER:

"USES ABUSIVE OR INSULTING LANGUAGE OF A NATURE LIKELY TO
CREATE DISORDER."

RESPONSE TO PETITION

Hon. Mr. Kimmerly, Minister of Justice, responded to Petition #4 as follows:

On November 24, 1986 the Legislature accepted for filing Petition #4 which concerns the actions of the Yukon Medical Council as they relate to an inquiry into the medical practice of Dr. D.W. Branigan.

The Medical Profession Act establishes the appointment of the Yukon Medical Council. The Council is a quasi-judicial body with the authority to investigate, enquire into and, when necessary, discipline members of the medical profession.

The question of peer review and discipline is common in all self- or partially self-regulating professions. However, we recognize that in our jurisdiction there is limited membership in the profession and occasionally allegations of bias will be raised. In order to avoid future concerns in this area I will be introducing a Bill to amend the Medical Profession Act which will permit the Yukon Medical Council to delegate its judicial functions to a provincial College of Physicians and Surgeons.

I am informed that the complaints against Dr. Branigan are still before the Yukon Medical Council. As the Council is a

quasi-judicial body involved in an investigation process it would be improper for me to comment further.

SPEAKER'S RULING

BEFORE PROCEEDING WITH ORDERS OF THE DAY, THE CHAIR WOULD LIKE TO PROVIDE THE HOUSE WITH RULINGS ON TWO POINTS OF ORDER WHICH WERE RAISED ON DECEMBER 4, 1986.

THE FIRST WAS RAISED BY THE MEMBER FOR WHITEHORSE PORTER CREEK EAST FOLLOWING REMARKS MADE BY THE GOVERNMENT LEADER DURING QUESTION PERIOD. DURING A REPLY TO A QUESTION FROM THE MEMBER FOR WHITEHORSE RIVERDALE SOUTH THE GOVERNMENT LEADER SAID:

"THE MEMBER HAS ASKED QUESTIONS ABOUT THAT CONTRACT, AND EVERY QUESTION HAS BEEN ANSWERED. NONETHELESS, SHE HAS MADE ACCUSATIONS PUBLICLY, WHICH ARE UNFOUNDED. I AM WAITING FOR HER TO MAKE THEM IN THE HOUSE. IF SHE DOES, I WILL CHALLENGE HER TO PUT HER SEAT ON THE LINE AND DEFEND THEM, BECAUSE THEY ARE FALSE."

FOLLOWING DISCUSSION ON THE POINT OF ORDER THE GOVERNMENT LEADER, IN RESPONSE TO A SUPPLEMENTARY QUESTION FROM THE MEMBER FOR WHITEHORSE RIVERDALE SOUTH, SAID:

"LET ME APOLOGIZE TO THE MEMBER OPPOSITE IF I GAVE HER OFFENCE AS I AM PERFECTLY WILLING TO DISCUSS THE MATTER PRIVATELY."

WHEN AN APOLOGY IS OFFERED OR WORDS WITHDRAWN IT IS NOT THEN NECESSARY FOR THE CHAIR TO DEAL WITH A MATTER ANY FURTHER. I WOULD ASK THAT MEMBERS BE CAREFUL IN MAKING REMARKS WHICH MAY BE INTERPRETED AS BEING THREATENING AS ANNOTATION 326 IN BEAUCHESNE STATES: "THREATENING LANGUAGE IS ALSO UNPARLIAMENTARY."

THE SECOND POINT OF ORDER WAS ALSO RAISED BY THE MEMBER FOR WHITEHORSE PORTER CREEK EAST AND WAS IN RESPONSE TO REMARKS MADE BY THE MINISTER OF RENEWABLE RESOURCES IN WHICH HE SAID:

"IF THEY DO OTHERWISE, I THINK, THEY ARE MAKING THE STATEMENT THAT THEY HAVE COMMITTED THEMSELVES TO A FORM OF LEGISLATIVE TERRORISM, TO PUT IT IN GRAPHIC TERMS THAT CAN BE BEST UNDERSTOOD."

I SAID, AT THAT TIME, THAT THERE MIGHT BE A CASE OF UNPARLIAMENTARY LANGUAGE BUT THAT I WOULD LIKE TO REVIEW THE MATTER. BOTH OUR STANDING ORDERS AND BEAUCHESNE STATE THAT IT

IS UNPARLIAMENTARY TO IMPUTE TO ANY MEMBER OR MEMBERS UNWORTHY OR BAD MOTIVES FOR THEIR ACTIONS IN A PARTICULAR CASE. ANNOTATION 320 IN BEAUCHESNE SHOWS THAT REMARKS ACCUSING MEMBERS OF OBSTRUCTING THE HOUSE HAVE BEEN RULED BOTH UNPARLIAMENTARY AND PARLIAMENTARY. ALTHOUGH THIS WOULD SEEM TO LEAVE SOME ROOM FOR ARGUMENT AS TO PROPER PARLIAMENTARY LANGUAGE THE CHAIR FEELS THAT THE TERM "LEGISLATIVE TERRORISM" LEAVES LITTLE DOUBT AS TO ITS MEANING AND SHOULD BE RULED AS BEING UNPARLIAMENTARY. THE CHAIR WOULD, THEREFORE, ASK THE MINISTER OF RENEWABLE RESOURCES TO NOW WITHDRAW THAT REMARK.

A member will be called to order by the Speaker if that member refers to any matter that is pending in a court or before a judge for judicial determination where any person may be prejudiced in such matter by the reference.

This Standing Order is qualified by rule number 11 of our Guidelines for Oral Question Period. This rule states:

A question is out of order if it deals with a matter that is before a court. In civil matters, however, this restriction will not apply unless and until the matter is at trial.

The matter which was being discussed yesterday is a civil matter and is not yet at the trial stage so questions respecting it are in order.

The Chair would ask that Members be careful in the phrasing of their questions since it is clear from rule number 2 of the Guidelines for Oral Question Period and annotations 358 and 359 in Beauchesne that it is not in order to ask for a legal opinion.

The Chair would also refer Members to annotation 339 in Beauchesne which outlines the position of the Speaker with respect to matters which are before the courts. That annotation states:

[T]he responsibility of the Speaker during the question period should be minimal as regards the sub-judice convention, and that the responsibility should principally rest upon the Member who asks the question and the Minister to whom it is addressed. However, the Speaker should remain the final arbiter in the matter but should exercise his discretion only in exceptional cases. In doubtful cases he should rule in favour of debate and against the convention.

The Assembly received the Administrator in his capacity as Lieutenant-Governor to give Assent to certain Bills passed by the House.

The Administrator, having entered the Chamber, took his seat in the Speaker's Chair.

The Speaker addressed the Administrator:

"Mr. Administrator, the Assembly has at its present Session passed a number of Bills to which in the name and on behalf of the Assembly, I respectfully request your Assent."

The Clerk of the Assembly then read the titles of the Bills that had been passed severally as follows:

Bill #7 - First Appropriation Act, 1987-88

Bill #79 - An Act to Amend the Medical Profession Act

Bill #99 - Human Rights Act

The Administrator assented the Bills:

"I hereby Assent to the Bills as enumerated by the Clerk."

The Administrator then retired from the Chamber.

ADJOURNMENT MOTION

Moved by the Hon. Mr. Porter:

THAT the House, at its rising, do stand adjourned until it appears to the satisfaction of the Speaker, after consultation with the Government Leader, that the public interest requires that the House shall meet;

THAT the Speaker give notice that he is so satisfied, and thereupon the House shall meet at the time stated in such notice and shall transact its business as if it had been duly adjourned to that time; and

THAT, if the Speaker is unable to act owing to illness or other causes, the Deputy Speaker shall act in his stead for the purpose of this order.

The question being put, it was agreed to.

The Assembly adjourned at 5:19 p.m.
