1. Motion #48 – Mr. Cable, Member for Riverside Carried November 17, 1993

THAT it is the opinion of this House that the Human Rights Commission should appear before this House, during the current session, to report to this House and advise on:

- (1) The status of race relations in Yukon;
- (2) What activities have been carried out by the Commission to foster improved race relations; and
- (3) What the Members of this House, and community leaders, may do to improve race relations in the Yukon community.

THAT it is the opinion of this House:

- (a) that a policy of Zero Tolerance of violence against women and children is a valuable and important tool for ensuring that response to violence, or threatened violence, is quick, efficient, effective, and thorough; and
- (b) that any initiatives taken in support of this policy should be designed and implemented in concert with First Nations, law enforcement agencies and the Integration '93 Committee, so that there is a co-ordinated and consistent response.
