#### SPEAKER'S STATEMENT (Re: Welcome and decorum)

Prior to proceeding with the Daily Routine, Speaker Laxton made the following statement:

"Premier Pasloski, leaders of the opposition, esteemed Members, visitors young and old, fellow Yukoners. This is the start of the 2012 Spring Sitting of the 33<sup>rd</sup> Legislative Assembly. We've had some time to get to know one another, having first convened as newly elected Members in December of last year. I stood then, as I stand now, to remind you about the trust you carry on behalf of every Yukon resident, no matter their political preferences or their fundamental beliefs.

As I look to the gallery and the visitors here, I know you folks want us — despite our innermost passion — to act with dignity, fairness and respect. This is not to say that we cannot press home our points with vigour and confidence. We were, after all, elected on particular platforms and every Member must be true to their platform, but it is vital in pressing these points, that we always recognize our larger constituency in each deliberation. I want every Yukoner and every visitor to be especially proud of this Assembly, to know that the public trust is in good hands. That's why I'm looking directly at you - the gallery, because you are the folks who will — at any given time — determine our value and, ultimately, our relevance.

It bears saying that I am honoured to be the Speaker of this Legislative Assembly and I know that every Member in this Chamber feels a distinct pride that comes with the responsibility that you have invested in us not so very long ago. That's why I again pledge my utmost to ensure that you will be well-served by Members and Speaker alike. I look forward to my fellow colleagues on both sides of me. I note the scene is set, that you're ready to discharge that trust. I said in my inaugural address that I take you to be both decent and honest. Now, with a sitting behind us and a second as yet untouched, I would add that you have proved steadfast in purpose and tenacious in approach. This is the way it should be.

No one needs to tell you that you're in the highest place of debate that Yukon can provide. You are entitled to your agendas, but others will watch how you conduct yourselves in pursuit of

those agendas. They will be poised to dismiss the best of intentions and the noblest of sentiments if you and I fail to live up to the decorum that we so carefully promised, yet can so easily lose.

Fight the good fight. But when the hour is done, look around to Members on all sides and indicate — however subtly — well fought; together we have put forward the day. Most importantly, we have kept the public trust, all the while knowing that we must earn it again tomorrow.

In closing, in December I said — and I say again now — that it's the duty of the Speaker to be impartial, to treat each Member equally and to make rulings that are both decisive and sound. In exchange, I look forward to this Spring Sitting that begins with promise and ends with a courage matched only by dignity. Yukoners, whether in the gallery or in their homes, deserve nothing less.

And so, to the business that awaits the day."

- (9) what sorts of consequences there will be for employees who engage in reckless or malicious accusations of wrongdoing and for managers who engage in reprisal against employees who act in good faith,

THAT the Committee report to the House its recommendation as to whether whistleblower protection legislation should include a sunset clause similar to that found in section 35 of the Ombudsman Act,

THAT the Committee have the power to call for persons, papers and records and to sit during inter-sessional periods,

# **SPEAKER'S RULING** (Re: Unparliamentary language and Speaker's role)

Prior to proceeding with Question Period, the Speaker, gave the following ruling pertaining to a Point of Order raised on Monday, April 2, 2012, during Question Period, by the Hon. Mr. Cathers, Government House Leader.

"Yesterday, during oral Question Period, the Member for Mount Lorne-Southern Lakes questioned the Minister of Community Services with regard to the minimum wage in Yukon. During the course of his final supplementary question, the Member asked the Minister, 'Why did she mislead this House?' The Government House Leader then rose on a Point of Order, and said, 'For the Member to accuse another Member of this House of 'misleading' this House is a very serious accusation under our Standing Orders. I believe past practice is that such an accusation should not be made lightly.'

The Chair believes that such an accusation should not be made at all. Standing Order 19(h) says, 'A Member shall be called to order by the Speaker if that Member...charges another Member with uttering a deliberate falsehood.' The Chair believes that the words used by the Member for Mount Lorne-Southern Lakes, in the context in which they were used yesterday, violated Standing Order 19(h).

As annotation 494 in the sixth edition of Beauchesne's <u>Parliamentary Rules and Forms</u> says, 'It has been formally ruled by Speakers that statements by Members respecting themselves and particularly within their own knowledge must be accepted. It is not unparliamentarily temperately to criticize statements made by Members as being contrary to the facts; but no imputation of intentional falsehood is permissible. On rare occasions this may result in the House having to accept two contradictory accounts of the same incident.'

On a related point, the Member for Mount Lorne-Southern Lakes said, in his defence, 'Mr. Speaker, I respectfully request that you review *Hansard* from Tuesday, March 27, to determine whether 'misled' is out of order.'

Members should appreciate that the Speaker's role in presiding over Question Period is to ensure Members follow the established rules and practices. The Speaker is not empowered to determine the truth or accuracy of statements made by Members. Neither can the Speaker determine if an inaccuracy in a statement made by a Member has been offered deliberately or not.

The Chair appreciates that all Members of this House hold their views with some conviction and disagree, sometimes quite strongly, with views expressed by other Members. Members are free to present their own version of the facts and to question the facts presented by others. However, Members should at all times treat each other with respect. Accusing another Member of deliberately misleading the House does not meet the standard."

#### **SPEAKER'S STATEMENT (Re: Relevance in debate)**

Prior to proceeding with Orders of the Day, the Speaker made the following statement regarding the Points of Order raised on April 18 during debate on Motion #162:

"These points of order raised by Members of the Official Opposition questioned the relevance of statements made by Members of the Government Caucus with regard to Motion #162. Standing Order 19(b)(i) says, 'A member shall be called to order by the Speaker if that member speaks to matters other than the question under discussion'. In other words, when members speak to a motion, their comments must be relevant to the motion before the House.

The procedural authorities recognize the importance of the rule of relevance. The second edition of <u>House of Commons Procedure and Practice</u>, at page 620 says, 'The requirement that speeches remain relevant to the question before the House flows from the latter's right to reach decisions without undue obstruction and to exclude from debate any discussion not conducive to that end.'

The authors go on to note that neglecting the rule of relevance would seriously impair the ability of the House to manage its time efficiently.

However, these authorities also recognize the difficulty of enforcing the rule. Because, to again quote <u>House of Commons Procedure and Practice</u>, 'Such enforcement must respect the freedom of debate enjoyed by all members.... It is not always possible to judge the relevance...of a member's remarks until he or she has spoken at some length or even completed his or her remarks. In practice, the Speaker allows some latitude — if the rules are applied too rigidly, they have the potential for severely curtailing the debate; if they are neglected, the resultant loss of debating time may prevent other members from participating in debate.'

Given the inherent limitations on the Chair in determining the relevance of Members' remarks, it is clear that Members themselves must have a measure of responsibility in ensuring that debate is relevant and orderly.

The Chair has noticed that members occasionally feel the need to comment on the manner in which other Members contribute to debate. It is such remarks that led to the Points of Order raised yesterday.

It is difficult for the Chair to determine if commenting on the manner in which other Members have contributed to a previous debate is relevant to the matter before the House. Nonetheless, Members might wish to reflect on whether such comments contribute to, or detract from, the level of order and decorum that the Members wish to see in this House. "

In this letter these Members revisit that Point of Order. They also request that the Leader of the Official Opposition 'apologize to the legislature at the earliest possible opportunity.'

The Chair would remind Members that Standing Order 6(1) says: 'the Speaker shall preserve order and decorum, and shall decide questions of order. In deciding a question of order or practice, the Speaker may state the standing order or other authority applicable to the case. No debate shall be permitted on any such decision, and no decision shall be subject to an appeal to the assembly.'

In other words, the Speaker's ruling on a Point of Order is final.

In writing this letter to the Leader of the Official Opposition, and in seeking redress directly from her, the Members in question have implicitly criticized the Speaker's handling of this Point of Order.

That is not acceptable.

There will be times when Members disagree with rulings from the Chair. Members will simply have to accept those rulings.

It is not appropriate for Members to attempt to discipline other Members on their own.

To do so demonstrates a lack of confidence in the Speaker who was elected by this House to preserve order and decorum."

In his defence, the Minister said that he was not using the word to describe the position of the Member for Mount Lorne-Southern Lakes. Rather, the Minister said, 'I did say it would be hypocritical of him to argue against housing in his backyard if that's what he was doing while saying housing is in a crisis.'

The Chair believes there is a Point of Order in this case. Members will recall that on March 22 of this year, the Premier used the word 'hypocrisy' to describe statements made by the Leader of the Official Opposition. The Chair ruled the use of the word out of order and the Premier withdrew the word.

The Chair appreciates that the Minister's use of the word yesterday, and the context in which it was used, were different from what occurred on March 22.

The Chair also appreciates that Members may, at times, find inconsistencies in statements made by other Members. However, using words like 'hypocrisy' and 'hypocritical' is problematic.

When used to describe the words or actions of another Member, those words carry a negative connotation, regardless of the intent of the person using them. These are words that are best avoided in any parliamentary context, hypothetical or otherwise.

The Chair thanks the Member for Copperbelt South and the Minister of Energy, Mines and Resources for their contribution to resolving this Point of Order."

## **SPEAKER'S STATEMENT** (Re: Standing Order 19(g))

Prior to proceeding with Question Period, the Speaker made the following statement regarding Standing Order 19(g).

"During yesterday's Question Period, in response to a question from the Member for Mayo-Tatchun regarding the Whitehorse Trough disposition process, the Minister of Energy, Mines and Resources said, 'I know the NDP does not support the mining industry...'

At that point, the Member for Mayo-Tatchun rose on a Point of Order and said that the Minister was imputing motives to the Official Opposition.

Standing Order 19(g) says, 'A member shall be called to order by the Speaker if that member imputes false or unavowed motives to another member.'

It is common for Members, during the course of debate and during Question Period, to offer their interpretation of the positions or policies of parties other than their own. These characterizations, which tend to be unflattering, frequently give rise to Points of Order. Procedurally speaking, characterizing a party's policies or positions in an unflattering manner is not the same as attributing a false or unavowed motive to another Member.

To violate Standing Order 19(g), a Member would have to suggest that another Member's reason for advocating a certain policy or position was one that is unworthy of an honourable Member of this Assembly. For example, in a past Legislative Assembly, the Chair invoked Standing Order 19(g) where a Member said that another Member adopted a certain position in order to put partisan self-interest ahead of the public interest.

The Chair does not believe that something similar to that occurred yesterday. Therefore, the Chair does not believe there is a Point of Order in this case.

Determining the true nature of a party's policy or position on an issue is a matter for Members to resolve through the process of debate, questions and responses. It is not a matter of procedure on which the Speaker can rule.

The Chair would like to thank the Member for Mayo-Tatchun and the Minister of Energy, Mines and Resources for their contributions to resolving this Point of Order.

We will now proceed to Question Period."
