Refurbishment of the Mace

Prior to proceeding with the Daily Routine, the Speaker made the following statement.

“Prior to proceeding to Daily Routine, I would like to draw everyone’s attention to our Mace. Yukon’s Mace, which was acquired in 1972, was a gift from the Parliament of Canada. The Mace is made of sterling silver and is gold-plated. However, in recent years the Mace has been showing its age and this past summer we had it re-plated. Murdoch’s Gem Shop provides ongoing maintenance of the Mace; however, re-plating the Mace was a much bigger job.

The Ontario Legislative Assembly assisted us in finding a jeweller who could do this work. Corona Jewellery Company in Toronto, under the direction of Michael Minister, refurbished the Mace. Corona has experience with this specialized kind of work, having refurbished the Ontario Legislature’s Mace in 2009.

In re-plating and cleaning the Mace, Mr. Minister and his crew approached the task as one would approach an article of great historical significance. They started with almost forensic-like detailing. The Mace was photographed from multiple angles to ensure that, when reassembled, everything would fit properly together. Each piece was recorded and mapped and a guide of reassembly was produced.

Ultimately, there were over 50 pieces, each unique and crucial to the Mace. Special jigs were made to handle some of the larger pieces, one of which was over 12 inches long. When the Mace was made, many of the pieces were assembled using bolts that have been, over the years, frozen in place by heavy oxidation. To solve this problem, Corona manufactured a custom-made wrench that fit perfectly and allowed for the careful and proper torque to remove the bolts.

Because of the unique nature and the size of the pieces for the Mace and the fact that some areas were suffering from oxidation, it was decided that each piece would have to be hand-polished prior to reassembly to remove any tarnish. This would allow for a uniform and perfect finish.

Polishing took over 24 hours of work by hand. Prior to assembly, each piece was plated with nickel to slow the natural oxidation process that occurred on the original silver Mace. Each piece was then plated again, this time with yellow gold. The coats of arms of Canada and Yukon were plated in white gold to better show off the beautiful hand engravings that were done previously on the original Mace.

The Mace was ultimately reassembled into its former style and grace, and Mr. Minister assures me that no pieces were left over.

On behalf of the Yukon Legislative Assembly, I would like to thank the Legislative Assembly of Ontario for finding a jeweller to do the work, for safeguarding the Mace while it was in Ontario and for having Inspector Rick Boon, their operations manager, escort the Mace back to Whitehorse.

I'd also like to thank Corona Jewellery for the exemplary work they did. Thanks to them, the symbol of our democratic process has been restored to its original beauty."

During Question Period, the Member for Riverdale South asked the Minister of Health and Social Services a series of questions about patient discharge planning. First, however, he would take some time to, in his words, 'correct the record' with respect to statements made by the Member for Riverdale South during discussion of Motion No. 808, which took place last Wednesday.

For the record, Motion No. 808 did not deal with patient discharge planning, and the Member for Riverdale South did not mention patient discharge planning during her speech on that motion. The minister continued in the same vein in response to the first supplementary question from the Member for Riverdale South. The Member for Mayo-Tatchun then rose on a point of order, citing Specific Rule No. 9 under the Guidelines for Oral Question Period. The rule states: 'A reply to a question should be as brief as possible, relevant to the question asked, and should not provoke debate.'

The Chair, at the time, ruled that there was no point of order, as the Chair could not know what the minister was going to say until he had finished. Only then could the Chair know how the minister's response was tied to the question. Having reviewed the Blues and seeing the minister's words in their full context, the Chair now concurs with the Member for Mayo-Tatchun. The minister's response did violate Specific Rule No. 9.

A minister's response is rarely ruled out of order. In responding to oral questions, ministers are given wide latitude, and it is difficult for the Chair to judge the content of responses during Question Period. However, in keeping with Specific Rule No. 9, a minister's response must be relevant to the question.

By relevant, the Chair means that the minister's response must address the same subject as the question asked. A response to a question is not an opportunity for a minister to speak about any subject that may have been raised in the House. If the minister wishes to discuss statements made during debate on Motion No. 808, he can do so if the motion is called for debate a second time. If appropriate, matters raised by Motion No. 808 might also be addressed in Committee of the Whole during consideration of the Department of Health and Social Services. However, in order for Question Period to serve its purpose, ministers must confine their responses to the subject matter of the question put to them."

Correct procedure for changing previously identified private members’ business

The Speaker made the following ruling on a Point of Order raised during Committee of the Whole.

“Prior to proceeding with adjournment, the Chair will rule on a point of order raised earlier today by the Minister of Economic Development. The Chair realizes that the point of order was raised in Committee of the Whole but pertained to a matter that occurred earlier in the day when the Speaker was in the Chair.

During notice of opposition private members’ business, the Official Opposition House Leader identified certain motions for debate tomorrow. Later, during Committee of the Whole, the Official Opposition House Leader rose on a point of personal privilege to inform the House that she had misidentified the Official Opposition motion to be called tomorrow. She informed the Committee that she had spoken to other House Leaders about this change. No member objected to her statement at that time. Later, the Minister of Environment rose on a point of order to contest the statement made by the Official Opposition House Leader under the point of personal privilege. He asserted that the Government House Leader did not agree to the change put forward by the Official Opposition House Leader. He argued that changing the motion identified for debate required unanimous consent, not a statement on a point of personal privilege.

There have been occasions in the past when House Leaders have misidentified motions for debate, corrections have been offered to the House, and unanimous consent was not required. In the past, unanimous consent was only required when the change was brought forward on the day that the motion was to be debated, and I believe that has only happened once.

The intention here of the Official Opposition House Leader was to identify at the earliest possible time the error that she had made to allow people to prepare themselves appropriately for the debate tomorrow. If she had waited and done it tomorrow, then definitely unanimous consent would be required. As she has made the effort and identified that she did speak to the House Leaders, I only assume that, in making her point of privilege, they did in fact agree. I’m seeing that there are heads shaking. I was hoping to avoid this, but I don’t see any other options here.”

After the Hon. Mr. Cathers, Government House Leader, Ms. Stick, Official Opposition House Leader, and Mr. Silver, Leader of the Third Party, spoke to the Speaker's Ruling, the Speaker made the following statement:

"The Standing Orders provide for the members to identify motions to be brought forward the next day. The Standing Orders don't provide for any errors in statements and give no directions on how to correct an error in statement. I don't believe there was any intent for the opposition members to mislead the House. It was a mistake in her statement.

I'm going to let it stand but I would encourage that, if the members feel that we need to have a way of correcting or dealing with these, they put forward something in the Standing Orders to give the Chair direction on how these things are supposed to be handled.

As I said earlier, if it had been on the day that the motion was being called, it would require unanimous consent. That makes sense. It was not. It was made today and it was made at the earliest possible moment. There were no objections raised at that particular time so I don't see any other way but allowing the member to change the motion number."

Standing Order 19(h)

Prior to proceeding with Oral Question Period, the Speaker made the following statement regarding Standing Order 19(h).

“Before proceeding to Question Period, having done substantial reviews of the Blues over the course of this entire sitting, there seems to be a little bit of confusion – in particular, with Standing Order 19(h): ‘A member shall be called to order by the Speaker if that member charges another member with uttering a deliberate falsehood’.

That being said, it is in order for one member to disagree with another member about facts. It is also in order for one member to disagree with another member about their interpretation of the facts. It is not for the Speaker to decide or rule on who is right or wrong about the facts.

However, it is not in order for one member to suggest that another member is knowingly or deliberately presenting inaccurate information to the House, nor is it in order for one member to suggest that another member is knowingly or deliberately misrepresenting statements made by others. To do so is a violation of Standing Order 19(h). I would like all the members to keep that in mind as we progress into our last two days.”
