- (2) the Whitehorse Aboriginal Women's Circle in hosting a Yukon family gathering, in December 2015 that will include family members of missing and murdered indigenous women and girls.

THAT this House urges the Government of Canada and the Government of Yukon to support the infrastructure needs of the north by providing new federal infrastructure funding that builds on the success of the Building Canada fund and meets the unique needs of Yukon communities by:

- (1) maintaining recognition of the challenges of delivering infrastructure in the north with the base-plus funding model and 75 percent federal, 25 percent territorial cost sharing;
- (2) ensuring streamlined, predictable approval timelines that establish clear criteria for project review and approval to ensure that projects are not delayed and can be implemented sooner;
- (3) increasing the flexibility of the funds to ensure that budget amendments during the life of the project are possible in recognition of the variables involved in developing northern civil infrastructure;
- (4) adopting a flexible approach to infrastructure categories; and
- (5) ensuring Yukon municipalities and Yukon First Nation governments are consulted as part of the decision making process.
