RE: REQUEST FOR 500 METER GREENBELT BUFFER ZONE AROUND NYGREN SUBDIVISION

On behalf of the residents of Nygren Subdivision, I am writing to request that the Yukon Government establish a 500 meter greenbelt buffer zone around the subdivision. When we purchased our properties in the 1990's, it was with the knowledge that there would never be any development next to us because we bordered the Wildlife Game Sanctuary, which was a major selling point at the time.

We just learned last week that in 2006 YTG changed the Rural Land Application legislation to allow development within the Wildlife Game Sanctuary. We, the residents at the time, were never informed of this change, so it came as quite a shock to learn of it now. In fact we tenaciously opposed Spot Application #2019-0191 in 2019 based on the longstanding knowledge that there would never be any permanent development in the Wildlife Game Sanctuary. Had we been aware of the legislation change, there would have been no need to challenge the application. Even still, we were not informed of the new rule.

The entire Nygren Subdivision was purchased by the Nygren family in 1902 and later subdivided into the current acreage lots. This was all privately owned land prior to the establishment of the Wildlife Game Sanctuary in the 1940's and Kluane National Park in the 1970's which borders on the Nygren Subdivision.

We now know that because of the legislation changes by YTG in 2006 anyone can apply for land around the Nygren Subdivision, and we feel the need to ensure a wide greenbelt buffer zone is in place before YTG approves any further development on our doorsteps, which is quite likely now that the Wildlife Game Sanctuary has been opened up for sale. The 500 meter greenbelt buffer zone will provide the necessary space needed between our properties and any future building that takes place in the Wildlife Game Sanctuary, especially if new subdivisions are a possibility.

A 500 meter greenbelt buffer zone will ensure the Wildlife Game Sanctuary around our subdivision remains intact to allow animal traffic for the bear, moose, deer, wolf, lynx, coyote, and rabbit populations that we see regularly moving through their habitat. There will be less risk of animal encounters within our subdivision if there is a permanent greenbelt zone for them.

Attached is a list of Nygren Subdivision residents who are in support of the proposed 500 meter greenbelt buffer zone.
