### **GOVERNMENT MOTIONS**

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

THAT the honourable Members Hon. Brad Cathers, Hon. Elaine Taylor, Steve Nordick, Don Inverarity and John Edzerza be appointed to the Standing Committee on Appointments to Major Government Boards and Committees established pursuant to Standing Order 45.

### **NOTICES OF MOTION**

### **GOVERNMENT MOTIONS**

1. Hon. Mr. Fentie (Motion #96)

THAT the Yukon Legislative Assembly, pursuant to section 2 of the *Ombudsman Act*, recommends that the Commissioner in Executive Council appoint Tracy-Anne McPhee as the Ombudsman of Yukon for a term of five years, effective April 9, 2007.

## MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Mitchell (Motion #97)

THAT this House urges the Government of Yukon to reduce the financial burden facing grandparents and other family members who want to care for their own grandchildren, nieces and nephews, without requiring them to go through the complete process of applying to be foster parents.

2. Mr. Elias (Motion #98)

THAT this House urges the Government of Yukon to comply with the *Environment Act*, section 46, sub-section 1, and table the Annual Report of the Yukon Council on the Economy and the Environment where the Council reports on its annual review of the performance of the Government of Yukon in the implementation of the Yukon Conservation Strategy.

3. Mr. Inverarity (Motion #99)

THAT this House urges the Yukon Government to conduct public consultations on the *Human Rights Act* and bring forward amendments in the 2997 Fall Sitting that:

- (1) ensure the *Human Rights Act* is more consistent with Human Rights Acts in other jurisdictions in Canada,
- (2) extend the timeline for filing a Human Rights complaint; and
- (3) and make the existing legislation, that is 20 years old, more relevant when it comes to protecting an individual's human rights.
- 4 Mr. Inverarity (Motion #100)

THAT this House urges the Yukon Government to bring forward legislation in the 2007 Fall Sitting to amend the *Workers' Compensation Act* based on the recommendations provided by the Workers' Compensation Act Review Panel.

5. Mr. Cardiff (Motion #101)

THAT this House urges the Yukon Government to provide stable, predictable, long-term funding for non-governmental organizations that provide programs on behalf of the Department of Justice so that:

- (1) non-governmental organizations will not continue to suffer from a lack of funding security; and,
- (2) these organizations can continue to serve the Yukon people without having to spend much of their time looking for funding, operating with below-standard salaries, and without appropriate administrative and training opportunities.

# 6. Mr. Edzerza (Motion #102)

THAT this House urges the Yukon Government to immediately contact Aurora College to reserve seats for Yukoners in the addictions training program that begins in September at its Inuvik campus, and to work with Yukon College to explore options for establishing a two-year certificate program in addictions counselling, in order to:

- (1) respond to the training needs for addictions counsellors in all Yukon communities,
- (2) prepare addictions counsellors for proposed community addictions treatment centres; and
- (3) act on the objectives in the Substance Abuse Action Plan.
