GOVERNMENT MOTIONS

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

3. Hon. Mr. Cathers (Motion #194)

THAT this House urges the Government of Yukon and the Yukon Registered Nurses Association to continue working together on the development of legislation that will allow Nurse Practitioners to work within their full scope of practice.

4. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

THAT this House urges the Department of Health and Social Services to launch a new health promotion initiative to:

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Nordick (Motion #690)

THAT this House urges the Canadian Broadcasting Corporation, in implementing any financial restraint measures, to keep intact its northern broadcasting system including the AM broadcast signal.

2. Mr. Nordick (Motion #691)

THAT this House urges the Yukon Government to proceed with the implementation of a number of priority initiatives identified in the Corrections Action Plan, some of which include:

- (1) the implementation of correctional reform through the ongoing operations of the Corrections Action Plan Implementation Office,
- (2) passage and implementation of the new Yukon Corrections Act, 2009 based on principles which provide for the rehabilitation, healing and reintegration of offenders into society,
- (3) the construction of a new Correctional Centre built in conjunction with a new Treatment Centre,
- (4) the implementation of the enhanced direct supervision model in the operation of the new Correctional Centre including human resource development and training for staff such as the Correctional Office Living Unit Training Model,
- (5) the construction of the Women's Transition Living Unit to meet the immediate needs of female inmates,
- (6) the operation of therapeutic courts such as the Community Wellness Court and the Domestic Violence Treatment Options Court,
- (7) work with First Nation governments, communities and NGO's to provide access to landbased camps/treatment centres for inmates of the Whitehorse Correctional Centre and offenders supervised in the community,
- (8) the continued implementation of the 5-Step FASD Action Plan,
- (9) the continued implementation of the Substance Abuse Action Plan which emphasizes harm reduction, prevention and education, treatment and enforcement; and
- (10) the enhancement of enforcement measures through the continued operation of the *Safer Communities and Neighbourhoods Act* and the RCMP Street Crime Reduction Team.
- 3. Mr. Nordick (Motion #692)

THAT this House urges the Government of Yukon to introduce amendments to legislation that will enable the enforcement of handicapped parking zones within the City of Whitehorse.

4. Mr. Mitchell (Motion #693)

THAT this House urges the Yukon Government to ensure that when Yukon highways are cleared of snow that:

(1) the entrance to Squatters Road is cleared of snow so as not to impede access to and from the highway in the interests of safety for people entering and exiting the Alaska Highway and Squatters Road intersection; and

- (2) a policy be developed and implemented for clearing the intersection of Yukon highways with other roads where no other level of government holds responsibility for doing so.
- 5. Mr. Cardiff (Motion #694)

THAT this House urges the Department of Education to work in partnership with parents in Burwash Landing to immediately set up a working group to promote the creation of a school and community cultural centre in Burwash Landing.
