**ORDERS OF THE DAY**

**GOVERNMENT MOTIONS**

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

3. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

## 4. Hon. Ms. Horne (Motion #713)

THAT this House urges the Government of Canada and its NATO allies to insist in the strongest possible terms that the Government of Afghanistan fully honour its human rights treaty obligations under international laws and demonstrate its commitment both in law and in practice to respect, protect and enforce the equality rights of the women of Afghanistan or face international sanctions.

## 5. Hon. Mr. Hart (Motion #723)

THAT this House urges the Government of Yukon to support the findings of the Motion #542 Consultation Report done by the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board, responding to Motion #542 adopted during the 2008 Fall Sitting of the Legislative Assembly, by requesting that the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board:

- (1) work together within their existing frameworks of authority to appropriately address areas of general consensus;
- (2) work together to ensure adequate training, orientation and supervision of young workers; and
- (3) conduct a review within 5 years to assess the effectiveness of any regulations resulting from this consultation and consider whether there is a need for a general minimum working age in Yukon.

## 6. Hon. Ms. Taylor (Motion #831)

THAT this House urges one member of the Official Opposition Caucus, one member of the Third Party Caucus and the Independent Member to accept the Yukon Government's invitation to attend the Climate Leaders Summit at COP15 in Copenhagen, Denmark, as observers from December 13-20, 2009.

## 7. Hon. Ms. Horne (Motion #832)

THAT this House urges the Government of Yukon to explore the concept of a multidisciplinary approach to dealing with the complex needs of chronic substance abusers.

## 8. Hon. Ms. Horne (Motion #935)

THAT this House urges the Government of Canada to meet its obligations under the Yukon First Nation Self-Government Agreements by providing sufficient financial resources to implement these agreements through the Assumption of Responsibilities Agreement (ARA) process; and to demonstrate this commitment by negotiating an appropriate ARA on the administration of justice with the Teslin Tlingit Council.

## 9. Hon. Ms. Taylor (Motion #941)

THAT this House urges the Government of Canada to work with Canada's tourism industry, provinces and territories and other stakeholders in the development of China Approved Destination Status policies and processes that will enable Canada's tourism sector to capitalize on this opportunity.

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Mitchell (Motion #947)  
THAT this House urges the Government of Yukon to provide interim funding to the Boys and Girls Club to ensure the club is able to continue operating to provide services for young people until stable long-term funding sources can be identified.
2. Mr. Mitchell (Motion #948)  
THAT this House urges the Government of Yukon to comply with the *Financial Administration Act* by ensuring that the Public Accounts, when tabled, are accompanied by the Auditor General's Report.
3. Mr. Hardy (Motion #949)  
THAT this House urges the Government of Yukon to work more closely with the people of Keno to ensure the proposed mine and mill in their community do not negatively impact on their quality of life or their ability to derive economic benefits from tourism-related activities.
4. Mr. Hardy (Motion #950)  
THAT it is the opinion of this House that the Prime Minister of Canada should listen to the facts on climate change and negotiate in good faith on a serious climate change agreement in Copenhagen that will ensure our survival on the planet.
