# MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Edzerza (Motion #842)

THAT this House urges the Government of Yukon to explore and bring forward civil forfeiture legislation that would allow the Government to seize the proceeds of criminal activity.

2. Mr. Edzerza (Motion #970)

THAT this House urges the Government of Yukon to ensure that Yukoners gain benefits from economic activity in the territory through the development of a locally-based skilled workforce in different disciplines of particular importance to Yukon relating to economic development, education, First Nation capacity building, health and social services and social justice by working in partnership with communities, Yukon First Nations, business and industry and Yukon College.

### **GOVERNMENT MOTIONS**

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

### 2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

### 3. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

### 4. Hon. Ms. Horne (Motion #713)

THAT this House urges the Government of Canada and its NATO allies to insist in the strongest possible terms that the Government of Afghanistan fully honour its human rights treaty obligations under international laws and demonstrate its commitment both in law and in practice to respect, protect and enforce the equality rights of the women of Afghanistan or face international sanctions.

### 5. Hon. Mr. Hart (Motion #723)

THAT this House urges the Government of Yukon to support the findings of the Motion #542 Consultation Report done by the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board, responding to Motion #542 adopted during the 2008 Fall Sitting of the Legislative Assembly, by requesting that the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board:

- (1) work together within their existing frameworks of authority to appropriately address areas of general consensus;
- (2) work together to ensure adequate training, orientation and supervision of young workers; and
- (3) conduct a review within 5 years to assess the effectiveness of any regulations resulting from this consultation and consider whether there is a need for a general minimum working age in Yukon.

# 6. Hon. Ms. Horne (Motion #832)

THAT this House urges the Government of Yukon to explore the concept of a multidisciplinary approach to dealing with the complex needs of chronic substance abusers.

### 7. Hon. Ms. Horne (Motion #935)

THAT this House urges the Government of Canada to meet its obligations under the Yukon First Nation Self-Government Agreements by providing sufficient financial resources to implement these agreements through the Assumption of Responsibilities Agreement (ARA)

process; and to demonstrate this commitment by negotiating an appropriate ARA on the administration of justice with the Teslin Tlingit Council.

8. Hon. Ms. Taylor (Motion #941)

THAT this House urges the Government of Canada to work with Canada's tourism industry, provinces and territories and other stakeholders in the development of China Approved Destination Status policies and processes that will enable Canada's tourism sector to capitalize on this opportunity.

### **NOTICE PAPER**

### MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Hardy (Motion #976)

THAT it is the opinion of this House that the Government of Canada should address the many troubling and alarming investments of Canadians' retirement dollars the Canadian Pension Plan Investment Board has made into war, environmental abuses and human rights violations around the world by:

- (1) appointing a labour and civil society representative to the CPPIB,
- (2) requiring the CPPIB to adhere to its Socially Responsible Investment policy for proxy voting,
- (3) reviewing the composition of the CPPIB to address and resolve conflicts of interest of current board members,
- (4) introducing legal and ethical screening legislation so that CPPIB investments are in compliance with international and domestic laws, as well as existing treaties; and
- (5) ending the use of the CPP as a tool for privatizing public services in Canada and internationally.
- 2. Mr. Hardy (Motion #977)

THAT this House urges the Yukon Government to create a Yukon Climate Change Investment Fund that would:

- (1) provide a local, accountable and transparent avenue for government officials and other Yukoners to pay into to offset the damage of air travel,
- (2) direct funds to support local green projects, including demonstration projects on alternative energy, local food production, renovating community buildings, and other projects which would not otherwise be funded through general government revenue,
- (3) be an arm's length government agency like a Crown corporation; and
- (4) be governed by a representative cross-section of Yukoners.
