GOVERNMENT MOTIONS

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

3. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

4. Hon. Ms. Horne (Motion #713)

THAT this House urges the Government of Canada and its NATO allies to insist in the strongest possible terms that the Government of Afghanistan fully honour its human rights treaty obligations under international laws and demonstrate its commitment both in law and in practice to respect, protect and enforce the equality rights of the women of Afghanistan or face international sanctions.

5. Hon. Mr. Hart (Motion #723)

THAT this House urges the Government of Yukon to support the findings of the <u>Motion #542 Consultation Report</u> done by the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board, responding to Motion #542 adopted during the 2008 Fall Sitting of the Legislative Assembly, by requesting that the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board:

- (1) work together within their existing frameworks of authority to appropriately address areas of general consensus;
- (2) work together to ensure adequate training, orientation and supervision of young workers; and
- (3) conduct a review within 5 years to assess the effectiveness of any regulations resulting from this consultation and consider whether there is a need for a general minimum working age in Yukon.

6. Hon. Ms. Horne (Motion #832)

THAT this House urges the Government of Yukon to explore the concept of a multidisciplinary approach to dealing with the complex needs of chronic substance abusers.

7. Hon. Ms. Horne (Motion #935)

THAT this House urges the Government of Canada to meet its obligations under the Yukon First Nation Self-Government Agreements by providing sufficient financial resources to implement these agreements through the Assumption of Responsibilities Agreement (ARA) process; and to demonstrate this commitment by negotiating an appropriate ARA on the administration of justice with the Teslin Tlingit Council.

8. Hon. Ms. Taylor (Motion #941)

THAT this House urges the Government of Canada to work with Canada's tourism industry, provinces and territories and other stakeholders in the development of China Approved Destination Status policies and processes that will enable Canada's tourism sector to capitalize on this opportunity.

9. Hon. Ms. Horne (Motion #1007)

THAT this House urges the Government of Canada to reinstate its funding for the Aboriginal Healing Foundation to ensure that the Kwanlin Dun First Nation, the Liard Aboriginal Women's Society, the Northern Tutchone Tribal Council, and the Committee on Abuse in Residential Schools Society (CAIRS), which have provided services to residential school survivors, can continue their programs.

10. Hon. Mr. Fentie (Motion #1017)

THAT this House urges the Government of Canada to recognize Yukon Self-Governing First Nations as a senior level of government, by working with the first seven Yukon First Nations

who settled their land claims to develop new Financial Transfer Agreements that include an economic development incentive allowing Yukon First Nations to retain an appropriate percentage of their own source revenues.

NOTICE PAPER

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. McRobb (Motion #1105)

THAT this House urges the Government of Yukon to introduce the necessary amendments to the *Highways Act* to allow two road accesses to land owned privately or commercially and to relax the enforcement of the archaic existing rules until the changes have been made.

2. Mr. McRobb (Motion #1106)

THAT this House urges the Government of Yukon to honour the commitments it made to citizens to standardize highway speed limits on the north Alaska Highway following the completion of road reconstruction under the Shakwak Project in the Kluane Region.

3. Mr. McRobb (Motion #1107)

THAT this House urges the Government of Yukon to honour the commitments it made to citizens with residences on the Papineau Road near Dezadeash Lake, and to work with the property owners to resolve outstanding issues related to the road right-of-way to enable all property owners to have legal road access to their properties.

4. Mr. McRobb (Motion #1108)

THAT this House urges the Government of Yukon to resolve issues relating to the road right-of-way through Silver City, near Kluane Lake, and make a reasonable offer to purchase the land from the owner in Alaska.

5. Mr. McRobb (Motion #1109)

THAT this House urges the Government of Yukon to work with all concerned individuals, agencies and governments towards the removal of the no-hunting corridor along the north Alaska Highway as it promised to do following the completion of road reconstruction under the Shakwak Project in the Kluane Region.

6. Mr. Cardiff (Motion #1110)

THAT this House urges the Government of Yukon to recognize the challenges it faces in recruiting one doctor for Dawson City and that recruiting a greater number of medical professionals for a new regional hospital in Dawson City requires serious thought and planning in terms of recruitment and retention.

7. Mr. Cardiff (Motion #1111)

THAT this House urges the Government of Yukon to work with the municipal government and conservation society in Dawson City in order to maximize the diversion of solid waste and recyclables by ensuring that:

- (1) proper infrastructure, including water and electricity, are in place at the Quigley landfill site,
- (2) staffing levels at the landfill and recycling depots are adequate; and
- (3) transportation of waste including tires, white metal and e-waste is coordinated and community groups are not overburdened by red tape.

8. Mr. Cardiff (Motion #1112)

THAT this House urges the Government of Yukon to work with citizens of Dawson City and the municipal government to address the critical housing shortage in Dawson City.
