THAT this House urges the Yukon Government to support development of the agriculture sector with actions including:

- (1) working with farmers and industry associations including Yukon Agriculture Association and the Grower's of Organic Food Yukon to implement the Agriculture Multi-Year Development Plan,
- (2) developing a "Yukon-Grown Food Policy" aimed at significantly increasing the production and use of locally-grown vegetables, meat and food products,
- (3) supporting the development of agriculture infrastructure that improves food security, facilitates access to market, and encourages local production of food,
- (4) supporting the development of local markets for Yukon agriculture products through measures including increasing the annual funding for the Fireweed Community Market; and
- (5) working with Yukon farmers to conduct agricultural research.

THAT this House urges the Government of Yukon to develop and implement a Yukon Water Strategy that will help provide long-term direction for economically and environmentally responsible development, management, and use of water in Yukon and establish principles to guide future decision making.

#### MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Ms. White (Motion #181)

THAT this House urges the Yukon Government to uphold the *Environment Act* and address persistent issues of its non-compliance with the law by:

- (1) bringing forward State of the Environment reports,
- (2) naming members to the Yukon Council on the Economy and the Environment,
- (3) bringing forward a new Yukon Conservation Strategy; and
- (4) addressing problems of efficiency and consistency around regulations and practices involving air emissions, recycling, waste, storage tanks and other issues raised by Government Audit Services.

#### 2. Mr. Silver (Motion #182)

THAT this House urges the Minister responsible for the Yukon Housing Corporation to investigate options to assist prospective home-builders to bridge the gap between the lower appraised values, based on existing homes, and the actual cost to build, by guaranteeing the gap that private banks will not lend based on the appraisal, but that home-builders otherwise have the income and stability to qualify for.

3. Mr. Elias (Motion #183)

THAT this House urges the Minister of Community Services to partner with the community of Old Crow to address current housing constraints by developing a new subdivision with serviced lots ready for new home construction.
