MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Ms. McLeod (Motion #283)

THAT this House urges the Government of Yukon, in keeping with the commitments outlined in its 2011 Election Platform, to implement initiatives and actions emanating from the <u>Our Towns, Our Future</u> review that included 75 findings in relation to the following 18 themes:

- (1) Yukon Government and Municipal Relations,
- (2) First Nation and Municipal Relations,
- (3) Regionalization and Governance,
- (4) Municipal Act Review Process,
- (5) Community Development Teams,
- (6) Municipal Sustainability Indicators,
- (7) Climate Change Adaptation,
- (8) Yukon Municipal Resources Website,
- (9) Provision of Local Services,
- (10) Municipal Infrastructure Deficit and Asset Management,
- (11) Revenue Generation,
- (12) Lot Development and Land Availability,
- (13) Comprehensive Municipal Grant,
- (14) Increasing Cost and Burden of Regulations,
- (15) Impacts of Peripheral Residents, Businesses, and Industries on Municipal Services,

- (17) Employee Recruitment and Retention; and
- (18) Training: Building Local Capacity.
- 2. Ms. McLeod (Motion #257)

THAT this House urges the Government of Yukon to form a multi-departmental committee consisting of the Departments of Education, Health & Social Services, and Justice, the Women's Directorate and the Youth Directorate to:

- (1) inventory their programs related to child welfare, cyber-safety, bullying, cyber-bullying, sexualized violence against children, and victims of crime,
- (2) review the existing and proposed programs to ensure a continuum of services,
- (3) examine partnerships with local organizations like parent groups and with agencies dedicated to child protection like the Royal Canadian Mounted Police and the Canadian Centre for Child Protection; and
- (4) conduct awareness campaigns periodically to assist Yukon students and parents in understanding the resources available to them.

GOVERNMENT MOTIONS

1. Hon. Mr. Dixon (Motion #119)

THAT this House urges the Government of Yukon to develop and implement a Yukon Water Strategy that will help provide long-term direction for economically and environmentally responsible development, management, and use of water in Yukon and establish principles to guide future decision making.

2. Hon. Mr. Cathers (Motion #211)

THAT this House urges the Yukon Government to continue to:

- (1) respect the fact that there are many hundreds of families in Yukon that depend upon mineral exploration in order to make their mortgage payments, feed themselves, and ensure a proper education and a bright future for their children; and
- (2) support responsible mineral exploration and responsible mining as key elements of a strong, diversified Yukon economy.
- 3. Hon. Mr. Dixon (Motion #212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.

That this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon.

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,

- (4) implement the recommendations of the <u>Sharing Common Ground</u> report.
