GOVERNMENT MOTIONS

1. Hon. Mr. Dixon (Motion #119)

THAT this House urges the Government of Yukon to develop and implement a Yukon Water Strategy that will help provide long-term direction for economically and environmentally responsible development, management, and use of water in Yukon and establish principles to guide future decision making.

2. Hon. Mr. Cathers (Motion #211)

THAT this House urges the Yukon Government to continue to:

- (1) respect the fact that there are many hundreds of families in Yukon that depend upon mineral exploration in order to make their mortgage payments, feed themselves, and ensure a proper education and a bright future for their children; and
- (2) support responsible mineral exploration and responsible mining as key elements of a strong, diversified Yukon economy.
- 3. Hon. Mr. Dixon (Motion #212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.
- 4. Hon. Mr. Kent (Motion #213)

That this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled

work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

5. Hon. Mr. Cathers (Motion #215)

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

6. Hon. Mr. Pasloski (Motion #216)

THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon.

7. Hon. Mr. Nixon (Motion #219)

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,
- (3) address street crime; and
- (4) implement the recommendations of the **Sharing Common Ground** report.

8. Hon. Mr. Dixon (Motion #241)

THAT this House urges the Government of Yukon to implement the 2012 Aishihik Bison Herd Management Plan, which includes allowing a Fall hunt in selected areas, reducing the cost of the seal from fifty dollars to ten dollars, and maintaining hunting as the primary management tool.

9. Hon. Mr. Kent (Motion #242)

THAT this House urges the Government of Yukon to implement initiatives that will enhance the safety of oil-fired appliances, including regulatory and/or legislative changes, public awareness and training initiatives for industry, based on the report of the Oil-Fired Appliance Working Group and input received from Yukon citizens, municipal and First Nation governments, industry and other interested groups during the community tour that took place in September and early October 2012.

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Ms. Hanson (Motion #354)

THAT this House urges the Government of Canada to not ratify the Canada-China Foreign Investment Promotion and Protection Agreement in order to allow a broad range of experts and stakeholders to engage in open and transparent study and debate, and to propose amendments regarding the impact of the agreement on the:

- (1) legislative jurisdiction of sub-national governments,
- (2) judicial sovereignty of Canada; and
- (3) national interest in Canada.

2. Ms. Hanson (Motion #355)

THAT this House urges the Yukon Government to provide support to extended families caring for children that:

- (1) establishes a special category of alternative care other than formal foster care that allows for a range of financial, social, training and counselling supports for caregivers,
- (2) recognizes the economic, social and preventative role of informal kinship care with financial supports not dependent on needs assessment, especially for pensioned grandparents and single kinship caregivers,
- (3) provides flexible, responsive and generous respite programs available on request for formal and informal kinship caregivers,
- (4) provides generous financial support including legal aid to assist with legal applications for custody, guardianship and adoption, especially when children have remained in the care of kin for extended periods,
- (5) provides child-care, financial, training and transportation support for counselling or for kinship caregiver self-support groups,
- (6) provides workshops and training in child rearing and current caregiving issues,
- (7) provides cross-cultural training for social workers dealing with First Nations people,
- (8) directs a section of the Family Law Information Centre to work with grandparents and extended families caregiving children; and
- (9) provides a telephone information system for advise and support for grandparents and extended families caregiving children.

3. Ms. Moorcroft (Motion #356)

THAT the Standing Committee on Rules, Elections and Privileges report to the House proposed amendments to the Standing Orders to remove Standing Order 76, also known as the "guillotine clause", that allows Government Bills to be passed on the final day of a Sitting of the Legislative Assembly without having received full debate

4. Mr. Tredger (Motion #357)

THAT this House urges the Government of Canada to support private member's Bill C-323, An Act to Amend the Federal Courts Act (International Promotion and Protection of Human Rights), standing in the name of Peter Julian, Member of Parliament for Burnaby-Westminster, to enact the Federal Court to hear claims for a host of universal human rights violations, such as genocide and torture, as well as activities that significantly destroy the environment or violate key international labour rights.
