#### GOVERNMENT PRIVATE MEMBERS' BUSINESS

#### MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Ms. McLeod (Motion #466)

THAT this House urges the Government of Yukon to develop a tourism, trade and investment mission to Europe and the United Kingdom led by the Premier to profile Yukon's tourism industry and investment opportunities for the purpose of:

- (1) increasing awareness of Yukon as a travel destination within European markets,
- (2) strengthening alliances with key business and government partners,
- (3) facilitating business to business partnerships; and
- (4) profiling investment opportunities within Yukon.
- 2. Mr. Hassard (Motion #473)

THAT this House urges Aboriginal Affairs and Northern Development Canada (AANDC) and the Canadian Northern Economic Development Agency (CanNor), in fulfillment of their shared mandates to support northern economic development, to:

- (1) respond positively to the April 2013 Senate Standing Committee on Transport and Communication report regarding the need for a national air travel strategy that takes into account specific needs and challenges of different regions, including the North; and
- (2) devise a Northern Air Travel Policy, as a component of a national air travel strategy, that encourages AANDC and CanNor employees travelling to, from, and within the North to select northern carriers over non-northern carriers, where the option to travel with a northern carrier exists and is priced within a margin of reasonable competitiveness.

#### **GOVERNMENT MOTIONS**

1. Hon. Mr. Dixon (Motion #119)

THAT this House urges the Government of Yukon to develop and implement a Yukon Water Strategy that will help provide long-term direction for economically and environmentally responsible development, management, and use of water in Yukon and establish principles to guide future decision making.

2. Hon. Mr. Cathers (Motion #211)

THAT this House urges the Yukon Government to continue to:

- (1) respect the fact that there are many hundreds of families in Yukon that depend upon mineral exploration in order to make their mortgage payments, feed themselves, and ensure a proper education and a bright future for their children; and
- (2) support responsible mineral exploration and responsible mining as key elements of a strong, diversified Yukon economy.
- 3. Hon. Mr. Dixon (Motion #212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.
- 4. Hon. Mr. Kent (Motion #213)

THAT this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

5. Hon. Mr. Cathers (Motion #215)

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

6. Hon. Mr. Pasloski (Motion #216)

THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon.

7. Hon. Mr. Nixon (Motion #219)

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,
- (3) address street crime; and
- (4) implement the recommendations of the **Sharing Common Ground** report.

8. Hon. Mr. Dixon (Motion #241)

THAT this House urges the Government of Yukon to implement the 2012 Aishihik Bison Herd Management Plan, which includes allowing a Fall hunt in selected areas, reducing the cost of the seal from fifty dollars to ten dollars, and maintaining hunting as the primary management tool.

9. Hon. Mr. Nixon (Motion #376)

THAT this House urges the Government of Yukon to recognize the important role that arts and culture play in contributing to the social and economic life of Yukon by providing assistance to arts and cultural organizations and Yukon artisans and by promoting exhibits, concerts, festivals, and multicultural events and programs.

10. Hon. Mr. Nixon (Motion #403)

THAT this House urges the Government of Yukon to assist Mothers Against Drunk Driving – Whitehorse in engaging other governments and agencies to implement a public awareness campaign with both general awareness advertising regarding the Report Impaired Drivers Program, and targeted signage focused on students celebrating graduation, boaters, and snowmobile operators at the Skagway and Haines summits.

1. Hon. Mr. Nixon (Motion #475)

THAT the Yukon Legislative Assembly, pursuant to section 22(2) of the *Human Rights Act*, appoint Vicki Hancock, Ashten Staffen and Patrick Rouble as members of the panel of adjudicators for terms of three years, effective May 19, 2013.

#### OTHER THAN GOVERNMENT MOTIONS

1. Ms. Moorcroft (Motion #476)

THAT this House urges the Government of Yukon to immediately:

- (1) fully implement Transport Canada's Safety Management System regulations at the Erik Neilson Whitehorse International Airport; and
- (2) provide to this House a copy of Yukon Government's Airports' Safety Policy, its comprehensive SMS training plan for all employees, and all other documents and requirements of the safety management system regulations.
- 2. Mr. Barr (Motion #477)

THAT this House urges the Government of Yukon to reduce bear habituation and the resulting bear-human conflict by improving sold waste management through:

- (1) examining the feasibility of, and working with, the City of Whitehorse and local manufacturers on a locking system for household curb-side bins; and
- (2) working with other municipal councils, First Nation governments, local advisory councils, and local waste management societies on bear-proof solutions for waste collection in incorporated and unincorporated communities.

THAT this House urges the Government of Yukon to work with Parks Canada, the Friends of Bear Creek Society and others to revitalize the Bear Creek site in Dawson City.
