ORDERS OF THE DAY

GOVERNMENT MOTIONS

1. Hon. Mr. Cathers (Motion No. 211)

THAT this House urges the Yukon Government to continue to:

- (1) respect the fact that there are many hundreds of families in Yukon that depend upon mineral exploration in order to make their mortgage payments, feed themselves, and ensure a proper education and a bright future for their children; and
- (2) support responsible mineral exploration and responsible mining as key elements of a strong, diversified Yukon economy.

2. Hon. Mr. Dixon (Motion No. 212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.

3. Hon. Mr. Kent (Motion No. 213)

THAT this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

4. Hon. Mr. Cathers (Motion No. 215)

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

5. Hon. Mr. Pasloski (Motion No. 216)

THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon.

6. Hon. Mr. Nixon (Motion No. 219)

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,
- (3) address street crime; and
- (4) implement the recommendations of the *Sharing Common Ground* report.

7. Hon. Mr. Dixon (Motion No. 241)

THAT this House urges the Government of Yukon to implement the 2012 Aishihik Bison Herd Management Plan, which includes allowing a Fall hunt in selected areas, reducing the cost of the seal from fifty dollars to ten dollars, and maintaining hunting as the primary management tool.

8. Hon. Mr. Nixon (Motion No. 376)

THAT this House urges the Government of Yukon to recognize the important role that arts and culture play in contributing to the social and economic life of Yukon by providing assistance to arts and cultural organizations and Yukon artisans and by promoting exhibits, concerts, festivals, and multicultural events and programs.

9. Hon. Mr. Nixon (Motion No. 403)

THAT this House urges the Government of Yukon to assist Mothers Against Drunk Driving – Whitehorse in engaging other governments and agencies to implement a public awareness campaign with both general awareness advertising regarding the Report Impaired Drivers Program, and targeted signage focused on students celebrating graduation, boaters, and snowmobile operators at the Skagway and Haines summits.

10. Hon. Mr. Kent (Motion No. 487)

THAT this House urges the Government of Yukon to ensure there is a continuing and abundant supply of clean and affordable power in Yukon in order to promote responsible and sustainable economic development, by:

- (1) directing the Yukon Development Corporation, as the agency designated by legislation as responsible for assuring a continuing and adequate supply of energy in Yukon, to commence the research and planning of a new hydroelectricity dam, based on the principles of scalability, environmental responsibility and First Nations engagement, as the centrepiece of a clean power future for Yukon;
- (2) exploring additional renewable sources such as wind and biomass as potential complements to the existing hydro-based grid;

- (3) exploring alternative sources that are cleaner and more affordable than diesel to facilitate the reduction of diesel consumption in those communities not connected to the existing hydro-based grid; and
- (4) ensuring there is a continuing supply of fossil fuels as a backup source to the hydro system and;
- (5) pursuing sources that are cleaner and more affordable than diesel for backup wherever possible.

11. Hon. Mr. Dixon (Motion No. 562)

THAT this House urges the Government of Canada, after receiving legal clarity from the Supreme Court of Canada, to consult with all provinces and territories on options for reforming the Senate of Canada.

12. Hon. Mr. Nixon (Motion No. 658)

THAT this House urges the Government of Yukon, in recognition of the Yukon Party's platform commitments to promote Yukon's tourism economy, to continue to study the technical and economic business case of further capital upgrades, including paving the runway at the Dawson City Airport, as part of the Government of Yukon's work with Air North, Yukon's airline, and Holland America to promote tourism to Yukon and the Klondike region through the use of tourism cooperative marketing agreements and strategic marketing campaigns.

13. Hon. Mr. Pasloski (Motion No. 755)

THAT this House urges the Government of Yukon to encourage parents, teachers, and Yukon's community as a whole to promote financial literacy and responsibility in Yukon's youth from an early age.

14. Hon. Mr. Graham (Motion No. 757)

THAT Bill No. 78, *Act to Amend the Marriage Act*, be reprinted and tabled in the Legislative Assembly in its reprinted form before the House proceeds with third reading and passage of the said bill.

15. Hon. Mr. Cathers (Motion No. 782)

THAT the Yukon Legislative Assembly, pursuant to subsection 7(1) of the *Child and Youth Advocate Act*, recommends that the Commissioner in Executive Council appoint Andrew Nieman as the acting Child and Youth Advocate, effective December 16, 2014.

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Elias (Motion No. 785)

THAT this House urges the Government of Yukon to undertake a tourism trade mission to Asia in order to realize the significant potential of Asian markets to Yukon's tourism industry and facilitate partnerships between government and industry that will benefit Yukon's tourism industry.

2. Ms. Hanson (Motion No. 786)

THAT this House mark the 25th anniversary of the unanimous resolution of the House of Commons of Canada to eliminate poverty among Canadian children by the year 2000 by committing to eliminating poverty among Yukon children

3. Ms. Moorcroft (Motion No. 787)

THAT this House urges the Government of Yukon to:

- (1) consider the findings of the report of the United Nations Special Rapporteur of the Human Rights Council on solitary confinement, and its harmful effects;
- (2) invite the Office of the Correctional Investigator Canada to audit Whitehorse Correctional Centre (WCC), including a review of the use of solitary confinement at WCC;
- (3) assess the impact of the use of solitary confinement on the physical and mental health of people in custody at WCC; and
- (4) provide recommendations based on the outcomes of the investigations.

4. Mr. Tredger (Motion No. 788)

THAT this House urges the Government of Yukon to work in collaboration with the Vuntut Gwitchin First Nation government to provide support to the community of Old Crow to ensure that affordable and healthy food is available to residents during the construction of the new food co-op.

5. Mr. Silver (Motion No. 789)

THAT this House urges the Government of Yukon to explore a community contribution company model similar to what is available in British Columbia, to:

- (1) bridge the gap between for-profit business and the not-for-profit sector;
- (2) encourage private investment into social enterprise; and
- (3) reduce demand for government contribution agreements.

6. Mr. Silver (Motion No. 790)

THAT this House urges the Government of Yukon to explain how holding a sod-turning event before an election campaign does not qualify as an election promise.

7. Mr. Hassard (Motion No. 791)

THAT this House urges the Government of Yukon to provide Yukoners with the fundamental skills necessary to prepare them for jobs, responsible citizenship and life-long learning by working in conjunction with First Nation governments, Yukon College and other stakeholders to

develop an inclusive, adaptable and productive workforce that contributes to and strengthens Yukon's economy.
