### ORDERS OF THE DAY

# **GOVERNMENT MOTIONS**

1. Hon. Mr. Cathers (Motion No. 211)

THAT this House urges the Yukon Government to continue to:

- (1) respect the fact that there are many hundreds of families in Yukon that depend upon mineral exploration in order to make their mortgage payments, feed themselves, and ensure a proper education and a bright future for their children; and
- (2) support responsible mineral exploration and responsible mining as key elements of a strong, diversified Yukon economy.
- 2. Hon. Mr. Dixon (Motion No. 212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.
- 3. Hon. Mr. Kent (Motion No. 213)

THAT this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

4. Hon. Mr. Cathers (Motion No. 215)

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

# 5. Hon. Mr. Pasloski (Motion No. 216)

THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon.

### 6. Hon. Mr. Nixon (Motion No. 219)

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,
- (3) address street crime; and
- (4) implement the recommendations of the *Sharing Common Ground* report.

### 7. Hon. Mr. Dixon (Motion No. 241)

THAT this House urges the Government of Yukon to implement the 2012 Aishihik Bison Herd Management Plan, which includes allowing a Fall hunt in selected areas, reducing the cost of the seal from fifty dollars to ten dollars, and maintaining hunting as the primary management tool.

### 8. Hon. Mr. Nixon (Motion No. 376)

THAT this House urges the Government of Yukon to recognize the important role that arts and culture play in contributing to the social and economic life of Yukon by providing assistance to arts and cultural organizations and Yukon artisans and by promoting exhibits, concerts, festivals, and multicultural events and programs.

### 9. Hon. Mr. Nixon (Motion No. 403)

THAT this House urges the Government of Yukon to assist Mothers Against Drunk Driving – Whitehorse in engaging other governments and agencies to implement a public awareness campaign with both general awareness advertising regarding the Report Impaired Drivers Program, and targeted signage focused on students celebrating graduation, boaters, and snowmobile operators at the Skagway and Haines summits.

### 10. Hon. Mr. Kent (Motion No. 487)

THAT this House urges the Government of Yukon to ensure there is a continuing and abundant supply of clean and affordable power in Yukon in order to promote responsible and sustainable economic development, by:

- (1) directing the Yukon Development Corporation, as the agency designated by legislation as responsible for assuring a continuing and adequate supply of energy in Yukon, to commence the research and planning of a new hydroelectricity dam, based on the principles of scalability, environmental responsibility and First Nations engagement, as the centrepiece of a clean power future for Yukon;
- (2) exploring additional renewable sources such as wind and biomass as potential complements to the existing hydro-based grid;

- (3) exploring alternative sources that are cleaner and more affordable than diesel to facilitate the reduction of diesel consumption in those communities not connected to the existing hydro-based grid; and
- (4) ensuring there is a continuing supply of fossil fuels as a backup source to the hydro system and:
- (5) pursuing sources that are cleaner and more affordable than diesel for backup wherever possible.

### 11. Hon. Mr. Dixon (Motion No. 562)

THAT this House urges the Government of Canada, after receiving legal clarity from the Supreme Court of Canada, to consult with all provinces and territories on options for reforming the Senate of Canada.

12. Hon. Mr. Pasloski (Motion No. 755)

THAT this House urges the Government of Yukon to encourage parents, teachers, and Yukon's community as a whole to promote financial literacy and responsibility in Yukon's youth from an early age.

15. Hon. Mr. Pasloski (Motion No. 820)

THAT this House urges the Minister of Aboriginal Affairs and Northern Development Canada to recognize Yukon First Nations governments as governments.

16. Hon. Mr. Cathers (Motion No. 839)

THAT the reporting deadline for the Select Committee Regarding the Risks and Benefits of Hydraulic Fracturing, established in Motion No. 662 of the First Session of the 33<sup>rd</sup> Legislative Assembly, be amended by changing said deadline from the 2014 Fall Sitting to January 19, 2015.

# **NOTICE PAPER**

### MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Hassard (Motion No. 840)

THAT this House urges the Government of Yukon to increase opportunities for Yukoners to harvest bison during the 2014-15 winter by lifting the mid-winter closure of the bison hunting season for nine wildlife management subzones that border the Alaska and north Klondike highways in the bison core range.

2. Ms. Hanson (Motion No. 841)

THAT this House urges the Government of Yukon to request that the Office of the Auditor General of Canada undertake an audit of the lease/purchase agreement between the Yukon government and Mountain View Golf Course.

3. Ms. Moorcroft (Motion No. 842)

THAT this House urges the Members' Services Board to consider implementing closed-caption services during all visual broadcasts of Assembly proceedings in order to make Yukon Legislative Assembly business more accessible.

4. Ms. Stick (Motion No. 843)

THAT this House urges the Government of Yukon to ensure all Yukoners have access to consistent mental health services by:

- (1) developing a protocol for follow up when an individual from a rural community has been released from hospital following a suicide attempt; and
- (2) implementing a policy requiring rural Yukon service providers who provide support to clients with serious, chronic mental health issues to collaborate with mental health service clinicians on management and support to individuals.
- 5. Ms. Stick (Motion No. 844)

THAT this House urges the Government of Yukon to consult with Yukoners with disabilities to develop and introduce legislation in the 2015 Spring Sitting that will support the rights of Yukoners with disabilities to equality, dignity, respect for difference, autonomy and inclusion, in accordance with Article 33 of the United Nations *Convention on the Rights of Persons With Disabilities*, by:

- (1) designating a single focal point within the Government of Yukon for matters related to the implementation of the United Nations *Convention on the Rights of Persons with Disabilities*;
- (2) establishing a framework, including an independent mechanism, to promote, protect and monitor implementation of the United Nations *Convention on the Rights of Persons with Disabilities*; and
- (3) ensuring that persons with disabilities and their representative organizations shall be involved and participate fully in the monitoring process.

6. Mr. Tredger (Motion No. 845)

THAT this House urges the Government of Yukon to work closely with the Village of Carmacks and the Little Salmon Carmacks First Nation to provide a budgetary allocation in the 2015-16 fiscal year and a development timeline to upgrade Carmacks' recreational facilities.

7. Mr. Silver (Motion No. 846)

THAT this House urges the Government of Yukon to table the terms of reference for the Yukon Hospital Corporation's quality management council.

8. Mr. Silver (Motion No. 847)

THAT this House urges the Government of Yukon to consult with Yukoners with disabilities to develop and introduce legislation that will support the rights of Yukoners with disabilities to equality, dignity, respect for difference, autonomy and inclusion, in accordance with article 33 of the United Nations *Convention on the Rights of Persons with Disabilities* by:
