GOVERNMENT MOTIONS

1. Hon. Mr. Dixon (Motion No. 212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.
- 2. Hon. Mr. Kent (Motion No. 213)

THAT this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

3. Hon. Mr. Cathers (Motion No. 215)

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

4. Hon. Mr. Pasloski (Motion No. 216) THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon. 5. Hon. Mr. Nixon (Motion No. 219)

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,
- (3) address street crime; and
- (4) implement the recommendations of the *Sharing Common Ground* report.
- 6. Hon. Mr. Nixon (Motion No. 376)

THAT this House urges the Government of Yukon to recognize the important role that arts and culture play in contributing to the social and economic life of Yukon by providing assistance to arts and cultural organizations and Yukon artisans and by promoting exhibits, concerts, festivals, and multicultural events and programs.

7. Hon. Mr. Kent (Motion No. 487)

THAT this House urges the Government of Yukon to ensure there is a continuing and abundant supply of clean and affordable power in Yukon in order to promote responsible and sustainable economic development, by:

- (1) directing the Yukon Development Corporation, as the agency designated by legislation as responsible for assuring a continuing and adequate supply of energy in Yukon, to commence the research and planning of a new hydroelectricity dam, based on the principles of scalability, environmental responsibility and First Nations engagement, as the centrepiece of a clean power future for Yukon;
- (2) exploring additional renewable sources such as wind and biomass as potential complements to the existing hydro-based grid;
- (3) exploring alternative sources that are cleaner and more affordable than diesel to facilitate the reduction of diesel consumption in those communities not connected to the existing hydro-based grid; and
- (4) ensuring there is a continuing supply of fossil fuels as a backup source to the hydro system and;
- (5) pursuing sources that are cleaner and more affordable than diesel for backup wherever possible.
- 8. Hon. Mr. Dixon (Motion No. 562)

THAT this House urges the Government of Canada, after receiving legal clarity from the Supreme Court of Canada, to consult with all provinces and territories on options for reforming the Senate of Canada.

9. Hon. Mr. Pasloski (Motion No. 755)

THAT this House urges the Government of Yukon to encourage parents, teachers, and Yukon's community as a whole to promote financial literacy and responsibility in Yukon's youth from an early age. 10. Hon. Mr. Pasloski (Motion No. 820)

THAT this House urges the Minister of Aboriginal Affairs and Northern Development Canada to recognize Yukon First Nations governments as governments.

11. Hon. Mr. Pasloski (Motion No. 851)

THAT this House urges the Government of Yukon to consult with settled and non-settled Yukon First Nations, as well as settled and non-settled trans-boundary aboriginal peoples, in accordance with land claims agreements, statutory obligations and the common law.

12. Hon. Mr. Pasloski (Motion No. 852)

THAT this House urges the Government of Yukon to continue to work closely with First Nation leadership and the Yukon RCMP through the enhanced First Nation policing model to support the Kwanlin Dun First Nation in their community safety planning efforts aimed at building wellness and security in the McIntyre subdivision.

13. Hon. Mr. Graham (Motion No. 853)

THAT this House urges the Government of Yukon to improve access to childcare by making the following changes to the Yukon child care subsidy funding program eligibility criteria:

- (1) increasing the income threshold by 5 percent;
- (2) increasing the maximum child care subsidy by 10 percent per eligible family;
- (3) decreasing the parent contribution rate by 3 percent for those families that exceed the eligible income threshold; and
- (4) re-wording the references to the applicant's ability to pay.
- 14. Hon. Mr. Graham (Motion No. 854)

THAT this House urges the Government of Yukon to continue moving forward with the planning and construction of a new 300-bed continuing care facility in recognition of Yukon's growing seniors population, while at the same time continuing to enhance home care for seniors in order that they can stay in their homes and home communities as long as possible.

15. Hon. Mr. Kent (Motion No. 855)

THAT this House urges the Government of Yukon to continue to work with First Nations to develop recreation lots in various areas in Yukon.

16. Hon. Mr. Kent (Motion No. 856)

THAT this House urges the Government of Yukon to work with the Yukon Hospital Corporation to ensure that there will be uninterrupted ambulance service from the Riverdale station during and following the hospital expansion.

17. Hon. Mr. Cathers (Motion No. 857)

THAT this House urges the Government of Yukon to continue to invest in firefighting response capacity by purchasing new equipment, such as the four new fire trucks purchased in 2014 which are now serving Ibex Valley, Tagish, Golden Horn and West Dawson.

18. Hon. Mr. Nixon (Motion No. 859)

THAT this House urges the Government of Yukon to continue to support the Community Wellness Court and the Justice Wellness Centre in responding to the needs of victims and in addressing recidivism and reoffending by extending the funding for an additional three years and looking for opportunities for partnership with other levels of government.

19. Hon. Mr. Istchenko (Motion No. 862)

THAT this House urges the Yukon government to continue functional planning on Yukon roads in order that Yukon is prepared for the growing demands for transportation infrastructure to support development within the territory.

20. Hon. Mr. Istchenko (Motion No. 863)

THAT this House urges the Yukon government to continue to work with its key stakeholders, the United States government, the Canadian government and its Alaskan counterparts in order to ensure Shakwak funding is reinstated to the United States federal transportation bill.

21. Hon. Mr. Dixon (Motion No. 864)

THAT this House urges the Government of Yukon to continue its commitment to employment equity by providing programs and supports through the workplace diversity employment office that have helped make the Yukon government one of the leaders among Canadian governments in assisting job seekers with disabilities.

22. Hon. Ms. Taylor (Motion No. 874)

THAT this House urges the Government of Yukon to continue to expand program offerings and work with communities in support of the Healthy Families Yukon and Learning Together programs.

23. Hon. Ms. Taylor (Motion No. 875)

THAT this House urges the Government of Yukon to work with the Government of Canada and industry stakeholders to create the Employer Sponsored Training stream of the Canada Job Grant in support of Yukon's labour market.

24. Hon. Mr. Nixon (Motion No. 876)

THAT this House urges the Government of Yukon to work in cooperation with Air North, industry partners, and cultural sector representatives in support of the Yukon government's commitment to promote Yukon as an attractive year-round destination during Winterlude.

25. Hon. Mr. Nixon (Motion No. 877)

THAT this House recognizes the contribution Yukon artists make to the territory and commend the Yukon government's partnership with the Friends of the Yukon Permanent Art Collection for wise stewardship of the Yukon Permanent Art Collection and the focus on fine craft in 2015 in honour of Craft Year 2015 in order to help promote craft as a key component of culture.

26. Hon. Mr. Nixon (Motion No. 878) THAT this House urges the Government of Yukon to continue to work in cooperation with the Government of Canada and the Royal Canadian Mounted Police to advance construction of a new RCMP detachment in Faro, in keeping with the public safety needs of the community. 27. Hon. Mr. Nixon (Motion No. 879)

THAT this House acknowledges the importance of Yukon's network of community-based museums in preserving, sharing, and celebrating the territory's rich heritage, now and into the future.

28. Hon. Mr. Nixon (Motion No. 880)

THAT this House urges the Government of Yukon to continue to provide services to child and youth victims and witnesses of crime by coordinating multi-disciplinary and inter-agency partners who provide services and programs, by applying national best practices for child advocacy centres to Yukon's northern context, by providing a child advocacy centre where a collaborative team of professionals work in a child-friendly setting to help a child or youth victim or witness navigate the criminal justice system, and by partnering with law enforcement, child protection, prosecutors, medical professionals, victim services and counseling services to provide an integrated support system for young victims and witnesses of crime and their families.

29. Hon. Mr. Pasloski (Motion No. 899)

THAT this House urges the professional staff of art curators and the director and chief executive officer of the National Gallery of Canada to give favourable consideration to include in the National Gallery's collection the work of an iconic and important figure in Yukon and Canadian art, the late Ted Harrison.

30. Hon. Mr. Cathers (Motion No. 907)

THAT the Yukon Legislative Assembly, pursuant to section 4 of the *Child and Youth Advocate Act*, recommends that the Commissioner in Executive Council appoint Annette King as the Child and Youth Advocate for Yukon for a term of five years, effective May 1, 2015.

GOVERNMENT MOTIONS

1. Hon. Mr. Kent (Motion No. 919)

THAT this House urges the Government of Yukon to responsibly develop Yukon's oil and gas industry, provide jobs and opportunities for Yukoners who are in Yukon and those currently working in other jurisdictions in this industry, and work to become a net contributor to Canada by:

- (1) developing a robust and advanced oil and gas regulatory regime;
- (2) being open to applications for hydraulic fracturing in the Liard Basin, less than two percent of Yukon's area, but only with the support of affected First Nations;
- (3) continuing a public dialogue to inform and educate Yukoners about oil and gas; and
- (4) performing the research and scientific and economic studies outlined in the recommendations from the Select Committee Regarding the Risks and Benefits of Hydraulic Fracturing so that additional baseline data and information is available.
- 2. Hon. Mr. Dixon (Motion No.920)

THAT this House urges the Government of Yukon to foster more efficient, globally competitive capital markets, increase protection for investors and strengthen national capacity to identify and manage capital markets-related systemic risks by signing onto the cooperative capital markets regulatory system.

3. Hon. Mr. Cathers (Motion No. 932)

THAT the Yukon Legislative Assembly, pursuant to subsection 22(2) of the *Human Rights Act*, does appoint Geneviève Chabot as a member of the Yukon Human Rights Panel of Adjudicators and, pursuant to subsection 22(2.01) of the *Human Rights Act*, does designate Geneviève Chabot as deputy chief adjudicator.

4. Hon. Mr. Cathers (Motion No. 933)

THAT the Yukon Legislative Assembly, pursuant to subsection 17(1) of the *Human Rights Act*, does appoint Russell Knutson as a member of the Yukon Human Rights Commission for a term of three years, effective April 30, 2015.

5. Hon. Mr. Cathers (Motion No. 934)

THAT the Yukon Legislative Assembly, pursuant to subsection 22(3) of the *Human Rights Act*, does remove Heather McFarlane and Elaine Cairns as members of the Yukon Human Rights Panel of Adjudicators.

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Ms. McLeod (Motion No. 921)

THAT this House urges the Government of Yukon to consult First Nations and industry stakeholders to develop a new biomass strategy that may include:

- (1) the development of a pilot district heating system;
- (2) private sector opportunities to heat Yukon government buildings;
- (3) reducing the reliance on oil and propane fuels; and
- (4) the development of opportunities for the local forestry industry.

2. Ms. McLeod (Motion No. 922)

THAT this House urges the Government of Yukon to use the 2015-16 budget to invest \$500,000 to support the development of the new Conrad campground on Tagish Lake's Windy Arm, in partnership with the Carcross-Tagish First Nation.

3. Ms. McLeod (Motion No. 923)

THAT this House urges the Government of Yukon to use the 2015-16 budget to invest in 911 service, including:

- (1) \$334,000 to move the current 911 call centre to the new Emergency Response Centre; and
- (2) \$733,000 to support hiring and training of additional 911 call centre staff, in order to allow for the expansion of basic 911 service to all Yukon communities.
- 4. Ms. McLeod (Motion No. 924)

THAT this House urges the Government of Yukon to use the community development fund to support the Watson Lake Daycare Centre Society to make improvements to their playground.

5. Mr. Elias (Motion No. 926)

THAT this House urges the Government of Yukon to continue moving forward with the planning and construction of a new 150-bed continuing care facility that is designed to provide for future expansion in recognition of Yukon's growing senior population, while at the same time continuing to enhance homecare for seniors in order that they can stay in their homes and home communities as long as possible.

6. Mr. Elias (Motion No. 927)

THAT this House urges the Government of Yukon to enhance the suite of energy incentive programs by adding:

- (1) a program that will assist Yukon apartment building and condominium owners in retrofitting their buildings to improve energy performance and reduce energy consumption, costs and emissions; and
- (2) a program that targets the lighting efficiency of commercial buildings by encouraging owners to upgrade to energy-efficient and long-lasting LED lighting systems.
- 8. Mr. Elias (Motion No. 928)

THAT this House urges the Government of Yukon to use the community development fund to restore and repair St. Paul's Anglican Church in Dawson City.

9. Mr. Elias (Motion No. 929)

THAT this House urges the Government of Yukon to use the community development fund to support the Tr'ondëk Hwëch'in First Nation in developing a complete UNESCO nomination dossier that meets World Heritage Convention requirements.

10. Mr. Elias (Motion No. 930)

THAT this House urges the Government of Yukon to implement the new northern wellness project with the Public Health Agency of Canada with the goals of:

- (1) improving wellness and preventing illness associated with modifiable risk factors;
- (2) building capacity at the community level to create enabling environments and opportunities for residents to improve their health and well-being;

- (3) reducing disparities in health status and removing barriers to engaging in healthy living activities and behaviours; and
- (4) promoting a healthy living cultural norm by emphasizing fun, learning connections, engagement, personal development and community pride.
- 11. Mr. Elias (Motion No. 931)

THAT this House urges the Yukon government to use the 2015-16 budget to allocate \$920,000 for new ambulances and fire trucks, including:

- (1) \$310,000 for two new ambulances; and
- (2) \$610,000 for two new fire trucks.
- 12. Ms. White (Motion No. 935)

THAT this House urges the Government of Yukon to acknowledge that:

- (1) without regulations in place, the *Residential Landlord and Tenant Act* that was assented to in 2012 cannot come into force; and
- (2) without the act or its regulations in force, landlords and tenants lack formal terms of reference on which to base their relationships, including the dispute resolution processes.
- 13. Mr. Silver (Motion No. 936)

THAT this House urges the Government of Yukon to retain the name "Sarah Steele Building" when it reopens the downtown alcohol and drug treatment centre.

14. Mr. Silver (Motion No. 937)

THAT this House urges the Government of Yukon to table the new formula it is using to calculate Yukon's visitation statistics.
