### Government Motions

1. Motion No. 133

Hon. Mr. Silver, Premier

THAT this House urges the Government of Yukon to practice sound financial management by:

- (1) recognizing the importance of including full future O&M costs when making new capital investments;
- (2) engaging with Yukoners to ensure that they have a say in deciding how to address current and future budget shortfalls;
- (3) reporting regularly to Yukoners on the financial health of the territory by way of economic outlooks and public accounts;
- (4) integrating fiscal forecasting with budget planning to improve accuracy of O&M and capital budgets; and
- (5) developing a predictable five-year capital plan.

### Motions Other Than Government Motions

1. Motion No. 134

Mr. Istchenko, Member for Kluane

THAT this House urges the Yukon government to recognize the importance of the aviation sector by keeping community aerodromes open and properly maintained, and abandoning the idea of shutting down five aerodromes.

2. Motion No. 135

Ms. White, Member for Takhini-Kopper King

THAT this House urges the Government of Yukon to ensure that the continuum of health care, including health care for seniors, is maintained in the public sector.

3. Motion No. 136

Ms. White, Member for Takhini-Kopper King

THAT this House urges the Government of Yukon to support inter-community transit options for Yukoners by:

- (1) lobbying Greyhound Canada and the British Columbia Transport Board to maintain the current level of services offered by Greyhound Canada; and
- (2) developing an affordable inter-community public transit service in collaboration with First Nation governments, municipalities and relevant businesses.

4. Motion No. 137

Mr. Istchenko, Member for Kluane

THAT this House urges the Government of Yukon to re-profile unspent funds budgeted for projects in the 2017-18 fiscal year toward initiatives to address public safety throughout Yukon.

## 5. Motion No. 138

Mr. Cathers, Member for Lake Laberge

THAT this House urges the Government of Canada to:

- (1) extend public consultation on its proposed changes to tax law affecting small businesses, farmers, placer miners, and medical practitioners;
- (2) ensure that Yukon citizens have an opportunity to fully participate in the public consultation, including holding public meetings in Yukon as requested by the Yukon Chamber of Commerce; and
- (3) provide written assurance to the Yukon Legislative Assembly that there will be no impacts on Yukon small businesses, farmers, placer miners, and medical practitioners as a result of these proposed tax changes.

## 6. Motion No. 139

THAT this House urges the Government of Yukon to not implement a territorial sales tax.

## 7. Motion No. 140

THAT this House urges the Government of Yukon to ensure that the RCMP have appropriate resources.

## 8. Motion No. 141

Mr. Cathers, Member for Lake Laberge

THAT this House condemns the Yukon government's decision to reduce the net financial assets from \$93.386 million on April 1, 2017 to the projected level of a paltry \$1.74 million in net financial assets at the end of the 2017-18 fiscal year.

## 9. Motion No. 142

Ms. McLeod, Member for Watson Lake

THAT this House urges the Yukon government to recognize the importance of Emergency Medical Services in Watson Lake by:

- (1) ensuring that there is no reduction in the number of staff positions in Watson Lake; and
- (2) working with EMS volunteers and the community of Watson Lake to review the current structure, and determine how best to provide additional support for Watson Lake EMS.
