**Government Motions**

1. Motion No. 133

Hon. Mr. Silver, Premier

THAT this House urges the Government of Yukon to practice sound financial management by:

- (1) recognizing the importance of including full future O&M costs when making new capital investments;
- (2) engaging with Yukoners to ensure that they have a say in deciding how to address current and future budget shortfalls;
- (3) reporting regularly to Yukoners on the financial health of the territory by way of economic outlooks and public accounts;
- (4) integrating fiscal forecasting with budget planning to improve accuracy of O&M and capital budgets; and
- (5) developing a predictable five-year capital plan.

2. Motion No. 256

Hon. Ms. McPhee, Minister of Justice

THAT the Yukon Legislative Assembly, pursuant to subsection 17(2) of the *Human Rights Act*, does remove Geneviève Chabot from the Yukon Human Rights Commission, effective immediately.

### Motions other than Government Motions

1. Motion No. 270

Ms. Hanson, Leader of the Third Party

THAT this House urges the Government of Yukon to immediately inform its employees regarding the change in the delivery of the employee assistance program and provide:

- (1) clear information regarding transition planning between the current service providers and the new employee assistance program providers; and
- (2) an uninterrupted and smooth transition from current service providers to the new employee assistance program providers.

2. Motion No. 271

THAT this House urges the Yukon government to introduce amendments to Bill No. 15, *Cannabis Control and Regulation Act*, to:

- (1) remove provisions that would grow the size of government by seeing government expand into the retail and distribution of cannabis; and
- (2) replace those clauses of Bill No. 15 with clauses that allow Yukon businesses to become licensed to sell and distribute cannabis in accordance with federal and territorial laws.

THAT this House urges the Government of Yukon to use the protection area provisions provided in the *Territorial Lands (Yukon) Act*, to protect and manage sensitive areas identified since 2012 from off-road vehicle use, before the spring of 2019.
