Motions Other Than Government Motions

1. Motion No. 274

Ms. Hanson, Leader of the Third Party

THAT this this House urges the Government of Yukon to immediately appoint an independent body with the requisite expertise to conduct a fully independent review of all aspects of the operations of Government of Yukon operated and/or funded group homes for children and youth;

THAT the review body be given access to:

- (1) current and former residents of Yukon group homes,
- (2) current and former staff of Yukon group homes, managers, directors and senior management responsible for Family and Children Services; and
- (3) any other materials or individuals as determined by the independent review body;

THAT the independent review body make recommendations for amendments to the *Child and Youth Advocate Act* to strengthen the independence and powers of the office of the Child and Youth Advocate to act in the best interest of children and youth; and

THAT this review body report to the Legislative Assembly no later than October 31, 2018.

THAT this House do issue an order for the return of all current applications for infrastructure funding that the Government of Yukon has submitted to the Government of Canada.

THAT this House urges the Government of Yukon to immediately inform its employees regarding the change in the delivery of the employee assistance program and provide:

- (1) clear information regarding transition planning between the current service providers and the new employee assistance program providers; and
- (2) an uninterrupted and smooth transition from current service providers to the new employee assistance program providers.
