## 1. Motion No. 469

Mr. Gallina, Member for Porter Creek Centre

THAT this House urges the Government of Yukon to launch an open data repository to put more government information in citizens' hands in order to support openness, transparency and economic diversification in the innovation, knowledge and IT sectors.

## 2. Motion No. 470

Mr. Istchenko, Member for Kluane

THAT this House urges Government of Yukon to explain to the residents of Destruction Bay and Burwash Landing, the Kluane First Nation and Yukoners:

- (1) why it was possible for maintenance to be done last summer at the Sheep Mountain boat launch on Kluane Lake; and
- (2) why the government claims similar maintenance can't be done at the Destruction Bay boat launch and marina in order to restore the use of this important access to the lake.

## 3. Motion No. 471

THAT it is the opinion of this House that the Premier has departed from the past practice of taking an all-party approach to considering changes to Yukon's elections laws by unilaterally announcing plans for an electoral reform commission whose members will be selected by him, follow terms of reference set by him and will report to him.

## 4. Motion No. 472

THAT this House urges the Government of Yukon to introduce legislation to ban conversion therapy of minors in Yukon and prohibit transporting minors outside of Yukon or Canada for such purposes, in order that the Legislative Assembly may pass such legislation as required and eliminate a practice that is seriously harmful and is opposed by the Canadian Psychological Association, the World Health Organization, the American Psychiatric Association and the American Medical Association.

## 5. Motion No. 473

THAT this House urges the Minister of Environment to ban the use or sale of neonicotionoids in order to protect Yukon's populations of pollinating species.
