1. Motion No. 407

THAT this House urges the Minister of Energy, Mines and Resources to abandon the Government of Yukon's plans to impose a 60-metre nodevelopment riparian buffer on titled property, beginning with titled land in the Shallow Bay zoning area.

2. Motion No. 408

THAT this House urges the Minister of Energy, Mines and Resources to respect the long-standing practice of ensuring that changes to zoning regulations provide new opportunities to some land owners and protect the current legal rights of all land owners.
